ORDER APPROVING TARIFF FILING

BY THE COMMISSION:

Through a tariff filing, AT&T Communications of the Southern States Inc. (ATT-C) is seeking to extend its promotion to offer discounts to customers who make bulk purchases of AT&T Prepaid Cards from April 29, 1995 through May 9, 1995. The duration of the bulk discount purchase promotion exceeds the 90 day maximum specified in Rule 25-24.485(1)(i), Florida Administrative Code (F.A.C.), which restricts promotional offerings to 90 days during any one year period. Accordingly, ATT-C seeks a waiver of that rule for the bulk purchases promotion.

In the same tariff filing as the bulk purchases promotion, ATT-C also seeks to offer a discount of 25% to customers who purchase AT&T Prepaid Cards from July 13, 1994, through September 15, 1994. This promotion is less than 90 days, therefore no rule waiver is necessary.

Upon consideration, we approve the tariff filing to extend the promotion to offer discounts to customers who make bulk purchases of AT&T Prepaid Cards, and also approve the requested waiver of Rule 25-24.485 (1)(i), Florida Administrative Code. We further approve the tariff filing to offer a 25% discount to customers who purchase AT&T Prepaid Cards from July 13, 1994, through September 15, 1994.

ORDERED by the Florida Public Service Commission that the tariff to offer discounts to customers who make bulk purchases of AT&T Prepaid Cards, filed by AT&T Communications of the Southern States Inc., is approved. It is further



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

The Commission's decision on this tariff is interim in nature and will become final, unless a person whose substantial interests are affected by the action proposed files a petition for a formal proceeding, as provided by Rule 25-22.036(4), Florida Administrative Code, in the form provided by Rule 25-22.036(7)(a)(d) and (e), Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting, 101 East Gaines Street, Tallahassee, Florida 32399-0870, by the close of business on August 23, 1994.

In the absence of such a petition, this order shall become final on the day subsequent to the above date.

Any objection or protest filed in this docket before the issuance date of this Order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this Order becomes final on the date described above, any party adversely affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the date this Order becomes final, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
