ORDER GRANTING FLORIDA PUBLIC UTILITIES COMPANY'S MOTION FOR
EXTENSION OF TIME AND APPROVING NEW DATES FOR FILING TESTIMONY

On January 6, 1995, Florida Public Utilities Company (FPUC or Company) filed its motion for an eleven day extension, until January 17, 1995, to furnish its responses to interrogatories nos. 15, 17, 28 through 35, 37, 41 and 42 and document requests nos. 3, 4, 9, 12, 13, and 14 propounded by staff. Staff does not object to the delay in receiving the Company's responses. Due to delay, however, staff needs additional time to evaluate the responses and assess whether staff will need to file testimony. Therefore, staff and the Company have mutually agreed to an eleven day extension to the dates to file staff testimony and rebuttal testimony. The revised dates are as follows:

Staff testimony	February 20, 1995	March 2, 1995
Rebuttal testimony	March 6, 1995	March 17, 1995

Upon consideration, FPUC's motion and the revision to the dates for filing staff testimony and rebuttal testimony are found to be reasonable and fair. All other dates in the Order Establishing Procedure in this docket (Order No. PSC-94-1485-PCO-GU, issued December 2, 1994), shall remain in effect.

In consideration of the foregoing, it is

ORDERED by Chairman Susan F. Clark, as Prehearing Officer, that Florida Public Utilities Company shall be allowed an eleven day extension to file its responses to the interrogatories and document requests described in the body of this order. It is further

ORDERED that the dates for filing staff testimony and rebuttal testimony are extended to March 2, 1995, and March 17, 1995, respectively. Order No. PSC-94-1485-PCO-GU is reaffirmed in all other respects.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
