ORDER GRANTING MOTION FOR EXTENSION OF TIME

In Order No. PSC-94-1313-FOF-EG, issued in this docket on October 25, 1994, we approved the adoption of numeric conservation goals for Tampa Electric Company (TECO). These goals were adopted pursuant to Rules 25-17.001 through 25-17.005, Florida Administrative Code, which require us to set demand side management (DSM) goals for Florida's electric utilities.

On January 6, 1995, TECO filed a Motion for Extension of Time. The motion requests an extension of time to allow TECO the opportunity to submit its DSM plan in a more carefully prepared manner.

The issues in this case are complex. TECO's assertion that it has been under time constraints in recent weeks is persuasive.

Based on the foregoing, it is therefore

ORDERED that Tampa Electric Company's Motion for Extension of Time is, hereby, granted. It is further

ORDERED that Tampa Electric Company's Demand-Side Management plan shall be filed with the Director, Division of Records and Reporting, before the close of business on February 6, 1995.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
