ORDER INDICATING NONJURISDICTIONAL STATUS OF
WILDWOOD HOLINESS CHURCH AND CLOSING DOCKET

BY THE COMMISSION:

On July 18, 1995, pursuant to Section 367.021(12), Florida Statutes, Mr. John Weaver filed an application with this Commission for recognition of nonjurisdictional status on behalf of Wildwood Holiness Church (Church). The Church will provide water services solely to its own facilities, without compensation. Wastewater services are received through a septic system. The Church is located at 6093 NE 53rd Boulevard, Wildwood, FL 34785. The mailing address is 5059 Country Road 144, Wildwood, FL 34785. The primary contact person is Mr. John Weaver, Pastor-President of the Church.

Upon request and sufficient proof, the Commission issues orders indicating the nonjurisdictional or exempt status of water or wastewater systems when they qualify under the appropriate provision of Chapter 367, Florida Statutes. The application was filed in accordance with Section 367.021(12), Florida Statutes, and Rules 25-30.060(1), (2), and (3)(j), Florida Administrative Code. The applicant states that the Church provides water service at no charge, and that all costs of providing service are treated or recovered as operational expenses. In addition, the applicant acknowledged Section 837.06, Florida Statutes, regarding false statements.

Section 367.021(12), Florida Statutes, defines utility as "every person . . . who is providing, or proposes to provide, water or wastewater service to the public for compensation." Based upon the facts as represented, the Church is not a utility as defined by Section 367.021(12), Florida Statutes, because it will not be providing service to the public for compensation. However, should there be any change in circumstances or in method of operation, the owner(s) of the Church, or any successor in interest, must inform the Commission within thirty days of such change, in order that we may determine whether the nonjurisdictional status of this entity remains appropriate. Because no further action is necessary, this docket shall hereby be closed.


Based upon the foregoing, it is, therefore,

ORDERED by the Florida Public Service Commission that, based upon the facts as represented, the water system of Wildwood Holiness Church, located at 6093 NE 53rd Boulevard, Wildwood, Florida, 34785, is not a utility subject to this Commission's jurisdiction pursuant to the terms of Section 367.021(12), Florida Statutes. It is further

ORDERED that should there be any change in circumstances or in method of operation of Wildwood Holiness Church's water system, the present owner(s) or any successor in interest shall inform the Commission within thirty days of such change. It is further

ORDERED that this docket is hereby closed.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
