ORDER GRANTING FLORIDA CITIES WATER COMPANY,
BAREFOOT BAY DIVISION'S MOTION FOR EXTENSION OF TIME
AND
REVISING ORDER ON PROCEDURE

On March 11, 1996, this Commission issued an Order Establishing Procedure (Order No. PSC-96-0338-PCO-WS) which established requirements for discovery, filings, notice, testimony and exhibits, prehearing statements, prehearing conference, waiver of issues, document identification, controlling dates, and the use of confidential information. According to that Order, Florida Cities Water Company, Barefoot Bay Division's (FCWC or utility) rebuttal testimony is due March 15, 1996.

On March 8, 1996, FCWC moved for a seven-day extension of time in which to file its rebuttal testimony and exhibits. In support of its motion, FCWC states that the direct testimony filed by the Staff and the Office of Public Counsel is technical in nature and will take considerable analysis before FCWC can prepare the rebuttal testimony. In addition, the utility states that it is preparing responses to Staff's discovery requests. The time for responding to FCWC's motion has not expired. However, the other parties in this docket state that they do not object to the motion, provided they are granted the same extension for filing rebuttal testimony.

In consideration of the above, FCWC's motion is granted. In order to allow time for FCWC to file its rebuttal testimony, and to provide all other parties the same amount of additional time in which to file rebuttal testimony, Order No. PSC-96-0338-PCO-WS, is hereby revised to the extent set forth below. The Order is reaffirmed in all other respects.


Based on the foregoing, it is
