ORDER APPROVING WITHDRAWAL OF PETITION  
AND VACATING ORDER NO. PSC-95-1488-FOF-TI

BY THE COMMISSION:

By Order No. PSC-94-1147-FOF-TI, issued September 16, 1994, this Commission approved the purchase of all outstanding stock of Total Telecommunications, Inc. d/b/a TTI (TTI) by TresCom USA, Inc. (TresCom). Since November 30, 1994, the effective date of the transfer, TTI has operated as a wholly owned subsidiary of TresCom.

On September 12, 1995, TresCom filed a petition for approval of a merger of TTI into TresCom and for the cancellation of TTI's Interexchange Telecommunications Certificate No. 2441, to be effective on or about January 1, 1996. We approved its request by Proposed Agency Action Order No. PSC-95-1488-FOF-TI, issued November 30, 1995.

By letter dated December 20, 1995, TresCom informed this Commission that it was unable to merge on or about January 1, 1996, due to its inability to receive all regulatory approval necessary to do so. Accordingly, TresCom requested to withdraw its petition for merger and for the cancellation of Certificate No. 2441.

Since TresCom is not able to go forward with the merger at this time, we approve its request to withdraw its petition for approval of the merger and for the cancellation of Certificate No. 2441, and vacate Order No. PSC-95-1488-FOF-TI.


It is, therefore,
