ORDER ESTABLISHING 1998 DOCKET NUMBER

BY THE COMMISSION:

In order to avoid confusion and reduce administrative handling problems in this active and continuing docket, we are establishing a new docket for the calendar year 1998. Beginning January 2, 1998, Docket No. 970004-EU, Planning Hearings on Load Forecasts, Generation Expansion Plans, and Cogeneration Prices for Florida's Electric Utilities will be identified as Docket No. 980004-EU.

The establishment of a new docket number is for administrative convenience only and the Commission retains its continuing jurisdiction over matters considered in previous planning dockets.

New docket numbers will be used by all parties on the effective date of January 2, 1998, and hereafter. Intervenors will not remain parties to this docket unless they notify the Division of Records and Reporting in writing of their intent to remain parties. Intervenors and interested persons must reestablish their status in order to remain on the docket mailing list.

Based on the foregoing, it is therefore

ORDERED by the Florida Public Service Commission that beginning January 2, 1998, all matters previously the subject of Docket No. 970004-EU, shall be part of Docket No. 980004-EU. It is further

ORDERED that the Commission shall retain jurisdiction over matters considered in previous planning dockets.



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: 1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; 2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or 3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
