ORDER APPROVING RESALE AGREEMENT

BY THE COMMISSION:

On October 16, 1997, BellSouth Telecommunications, Inc. (BellSouth) and Alternative Phone, Inc. (Alternative) filed a request for approval of a resale agreement under the Telecommunications Act of 1996, 47 U.S.C. §252(e) of the Telecommunications Act of 1996 (the Act). The agreement is attached to this Order as Attachment A and incorporated by reference herein.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

This agreement covers a two-year period and governs the relationship between the companies regarding the resale of tariffed telecommunication services. Under 47 U.S.C. § 252(a)(1), the agreement shall include a detailed schedule of itemized charges for interconnection and each service or network element included in the

agreement. The agreement states that telecommunications services provided by BellSouth for resale will be available for purchase by Alternative at a discount rate of 21.83% for residential services and 16.81% for business services.

Upon review of the proposed agreement, we find that it complies with the Telecommunications Act of 1996; thus, we hereby approve it. BellSouth and Alternative must file any supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the resale agreement between BellSouth Telecommunications, Inc. and Alternative Phone, Inc., as set forth in Attachment A and incorporated by reference in this Order, is hereby approved. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this docket shall be closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

SYNOPSIS

Pursuant to Sections 251 and 252 of the Telecommunications Act of 1996, BellSouth is filing an executed Resale Agreement by and between BellSouth Telecommunications, Inc. and Alternative Phone, Inc. in the state of Georgia.

The term of this Agreement shall be two years beginning September 16, 1997. This Agreement shall be automatically renewed for two additional one year periods unless either party indicates its intent not to renew the Agreement.

Alternative Phone may resell the tariffed local exchange and tell telecommunications services of BellSouth contained in the General Subscriber Services and Private Line Service Tariffs.

Attachment B is the executed Resale Agreement between BellSouth Telecommunications, Inc. and Alternative Phone, Inc.

Agreement Between BellSouth Telecommunications, Inc. and Alternative Phone, Inc. Regarding The Sale of BellSouth Telecommunications Services to Alternative Phone, Inc. For The Purposes of Resale

THIS AGREEMENT is by and between BellSouth Telecommunications, Inc., ("BellSouth or Company"), a Georgia corporation, and Alternative Phone, Inc. ("Alternative Phone"), a Florida corporation, and shall be deemed effective as of September 16, 1997.

WITNESSETH

WHEREAS, BellSouth is a local exchange telecommunications company authorized to provide telecommunications services in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee; and

WHEREAS, Alternative Phone is or seeks to become an alternative local exchange telecommunications company authorized to provide telecommunications services in the states of Alabama, Florida, and Georgia; and

WHEREAS, Alternative Phone desires to resell BellSouth's telecommunications services; and

WHEREAS, BellSouth has agreed to provide such services to Alternative Phone for resale purposes and pursuant to the terms and conditions set forth herein;

NOW, THEREFORE, for and in consideration of the mutual premises and promises contained herein, BellSouth and Alternative Phone do hereby agree as follows:

L Term of the Agreement

- A. The term of this Agreement shall be two years beginning September 16, 1997 and shall apply to all of BellSouth's serving territory as of January 1, 1997 in the states of Alabama, Florida, and Georgia;
- B. This Agreement shall be automatically renewed for two additional one year periods unless either party indicates its intent not to renew the Agreement. Notice of such intent must be provided, in writing, to the other party no later than 60 days prior to the end of the then-existing contract period. The terms of this Agreement shall remain in effect after the term of the existing agreement has expired and while a new agreement is being negotiated.
- C. The rates pursuant by which Alternative Phone is to purchase services from BellSouth for resale shall be at a discount rate off of the retail rate for the telecommunications service. The discount rates shall be as set forth in Exhibit A, attached hereto and incorporated herein by this reference. Such discount shall reflect the costs avoided by BellSouth when selling a service for wholesale purposes.

II. Definition of Terms

- A. CUSTOMER OF RECORD means the entity responsible for placing application for service; requesting additions, rearrangements, maintenance or discontinuance of service; payment in full of charges incurred such as non-recurring, monthly recurring, toll, directory assistance, etc.
- B. DEPOSIT means assurance provided by a customer in the form of cash, surety bond or bank letter of credit to be held by the Company.

- END USER means the ultimate user of the telecommunications services.
- D. END USER CUSTOMER LOCATION means the physical location of the premises where an end user makes use of the telecommunications services.
- E. NEW SERVICES means functions, features or capabilities that are not currently offered by BellSouth. This includes packaging of existing services or combining a new function, feature or capability with an existing service.
- F. OTHER LOCAL EXCHANGE COMPANY (OLEC) means a telephone company certificated by the public service commissions of the Company's franchised area to provide local exchange service within the Company's franchised area.
- G. RESALE means an activity wherein a certificated OLEC, such as Alternative Phone subscribes to the telecommunications services of the Company and then reoffers those telecommunications services to the public (with or without "adding value").
- H. RESALE SERVICE AREA means the area, as defined in a public service commission approved certificate of operation, within which an OLEC, such as Alternative Phone, may offer resold local exchange telecommunications service.

III. General Provisions

A. Alternative Phone may resell the tariffed local exchange and toll telecommunications services of BellSouth contained in the General Subscriber Service Tariff and Private Line Service Tariff subject to the terms, and conditions specifically set forth herein. Notwithstanding the foregoing, the exclusions and limitations on services available for resale will be as set forth in Exhibit B, attached hereto and incorporated herein by this reference.

BellSouth shall make available telecommunications services for resale at the rates set forth in Exhibit A to this agreement and subject to the exclusions and limitations set forth in Exhibit B to this agreement. It does not however waive its rights to appeal or otherwise challenge any decision regarding resale that resulted in the discount rates contained in Exhibit A or the exclusions and limitations contained in Exhibit B. BellSouth reserves the right to pursue any and all legal and/or equitable remedies, including appeals of any decisions. If such appeals or challenges result in changes in the discount rates or exclusions and limitations, the parties agree that appropriate modifications to this Agreement will be made promptly to make its terms consistent with the outcome of the appeal.

- B. The provision of services by the Company to Alternative Phone does not constitute a joint undertaking for the furnishing of any service.
- C. Alternative Phone will be the customer of record for all services purchased from BellSouth. Except as specified herein, the Company will take orders from, bill and expect payment from Alternative Phone for all services.

- D. Alternative Phone will be the Company's single point of contact for all services purchased pursuant to this Agreement. The Company shall have no contact with the end user except to the extent provided for herein.
- E. The Company will continue to bill the end user for any services that the end user specifies it wishes to receive directly from the Company.
- F. The Company maintains the right to serve directly any end user within the service area of Alternative Phone. The Company will continue to directly market its own telecommunications products and services and in doing so may establish independent relationships with end users of Alternative Phone.
- G. Neither Party shall interfere with the right of any person or entity to obtain service directly from the other Party.
- H. Current telephone numbers may normally be retained by the end user. However, telephone numbers are the property of the Company and are assigned to the service furnished. Alternative Puone has no property right to the telephone number or any other call number designation associated with services furnished by the Company, and no right to the continuance of service through any particular central office. The Company reserves the right to change such numbers, or the central office designation associated with such numbers, or both, whenever the Company deems it necessary to do so in the conduct of its business.
- I. The Company may provide any service or facility for which a charge is not established herein, as long as it is offered on the same terms to Alternative Phone.
- J. Service is furnished subject to the condition that it will not be used for any unlawful purpose.
- K. Service will be discontinued if any law enforcement agency advises that the service being used is in violation of the law.
- L. The Company can refuse service when it has grounds to believe that service will be used in violation of the law.
- M. The Company accepts no responsibility to any person for any unlawful act committed by Alternative Phone or its end users as part of providing service to Alternative Phone for purposes of resale or otherwise.
- N. The Company will cooperate fully with law enforcement agencies with subpoenas and court orders for assistance with the Company's customers. Law enforcement agency subpoenas and court orders regarding end users of Alternative Phone will be directed to Alternative Phone. The Company will bill Alternative Phone for implementing any requests by law enforcement agencies regarding Alternative Phone end users.
- O. The characteristics and methods of operation of any circuits, facilities or equipment provided by any person or entity other than the Company shall not:

IV. BellSouth's Provision of Services to Alternative Phone

- Alternative Phone agrees that its resale of BellSouth services shall be as follows:

Such efforts include, but are not limited to, sales referrals, resale arrangements, sales agencies or billing agreements. This subsection shall be void and of no effect for a particular state covered under this Agreement as of February 8, 1999 or on the date BellSouth is authorized to offer interLATA services in that state, whichever is earlier.

- 3. Hotel and Hospital PBX service are the only telecommunications services available for resale to Hotel/Motel and Hospital end users, respectively. Similarly, Access Line Service for Customer Provided Coin Telephones is the only local service available for resale to Independent Payphone Provider (IPP) customers. Shared Tenant Service customers can only be sold those telecommunications services available in the Company's A23 Shared Tenant Service Tariff.
- 4. Alternative Phone is prohibited from furnishing both flat and measured rate service on the same business premises to the same subscribers (end users) as stated in A2 of the Company's Tariff except for backup service as indicated in the applicable state tariff Section A3.
- 5. If telephone service is established and it is subsequently determined that the class of service restriction has been violated, Alternative Phone will be notified and billing for that service will be immediately changed to the appropriate class of service. Service charges for changes between class of service, back billing, and interest as described in this subsection shall apply at the Company's sole discretion. Interest at a rate as set forth in Section A2 of the General Subscriber Service Tariff and Section B2 of the Private Line Service Tariff for the applicable state, compounded daily for the number of days from the back billing date to and including the date that Alternative Phone actually makes the payment to the Company may be assessed.
- 6. The Company reserves the right to periodically audit services purchased by Alternative Phone to establish authenticity of use. Such audit shall not occur more than once in a calendar year. Alternative Phone shall make any and all records and data available to the Company or the Company's auditors on a reasonable basis. The Company shall bear the cost of said audit.
- B. Resold services can only be used in the same manner as specified in the Company's Tariff. Resold services are subject to the same terms and conditions as are specified for such services when furnished to an individual end user of the Company in the appropriate section of the Company's Tariffs. Specific tariff features, e.g. a usage allowance per month, shall not be aggregated across multiple resold services. Resold services cannot be used to aggregate traffic from more than one end user customer except as specified in Section A23. of the Company's Tariff referring to Shared Tenant Service.
- C. Alternative Phone may resell services only within the specific resale service area as defined in its certificate.
- D. Telephone numbers transmitted via any resold service feature are intended solely for the use of the end user of the feature. Resale of this information is prohibited.
- E. No patent, copyright, trademark or other proprietary right is licensed, granted or otherwise transferred by this Agreement. Alternative Phone is strictly prohibited from any use, including but not limited to sales, marketing or advertising, of any BellSouth name or trademark.

V. Maintenance of Services

- A. Alternative Phone will adopt and adhere to the standards contained in the applicable BellSouth Work Center Interface Agreement regarding maintenance and installation of service.
- B. Services resold under the Company's Tariffs and facilities and equipment provided by the Company shall be maintained by the Company.
- C. Alternative Phone or its end users may not rearrange, move, disconnect, remove or attempt to repair any facilities owned by the Company, other than by connection or disconnection to any interface means used, except with the written consent of the Company.
- D. Alternative Phone accepts responsibility to notify the Company of situations that arise that may result in a service problem.
- E. Alternative Phone will be the Company's single point of contact for all repair calls on behalf of Alternative Phone's end users. The parties agree to provide one another with toll-free contact numbers for such purposes.
- F. Alternative Phone will contact the appropriate repair centers in accordance with procedures established by the Company.
- G. For all repair requests, Alternative Phone accepts responsibility for adhering to the Company's prescreening guidelines prior to referring the trouble to the Company.
- H. The Company will bill Alternative Phone for handling troubles that are found not to be in the Company's network pursuant to its standard time and material charges. The standard time and material charges will be no more than what BellSouth charges to its retail customers for the same services.
- The Company reserves the right to contact Alternative Phone's customers, if deemed necessary, for maintenance purposes.

VI. Establishment of Service

A. After receiving certification as a local exchange company from the appropriate regulatory agency, Alternative Phone will provide the appropriate Company service center the necessary documentation to enable the Company to establish a master account for Alternative Phone. Such documentation shall include the Application for Master Account, proof of authority to provide telecommunications services, an Operating Company Number ("OCN") assigned by the National Exchange Carriers Association ("NECA") and a tax exemption certificate, if applicable. When necessary deposit requirements are met, the Company will begin taking orders for the resale of service.

The fact that a deposit has been made in no way relieves Alternative Phone from complying with the
- J. The Company reserves the right to increase the deposit requirements when, in its sole judgment, the conditions justify such action.
- K. In the event that Alternative Phone defaults on its account, service to Alternative Phone will be terminated and any deposits held will be applied to its account.

VII. Payment And Billing Arrangements

- A. When the initial service is ordered by Alternative Phone, the Company will establish an accounts receivable master account for Alternative Phone.
- B. The Company shall bill Alternative Phone on a current basis all applicable charges and credits.
- C. Payment of all charges will be the responsibility of Alternative Phone. Alternative Phone shall make payment to the Company for all services billed. The Company is not responsible for payments not received by Alternative Phone from Alternative Phone's customer. The Company will not become involved in billing disputes that may arise between Alternative Phone and its customer. Payments made to the Company as payment on account will be credited to an accounts receivable master account and not to an end user's account.
- D. The Company will render bills each month on established bill days for each of Alternative Phone's accounts.
- E. The Company will bill Alternative Phone, in advance, charges for all services to be provided during the ensuing billing period except charges associated with service usage, which charges will be billed in arrears. Charges will be calculated on an individual end user account level, including, if applicable, any charges for usage or usage allowances. BellSouth will also bill all charges, including but not limited to 911 and E911 charges, telecommunications relay charges, and franchise fees, to Alternative Phone.
- F. The payment will be due by the next bill date (i.e., same date in the following month as the bill date) and is payable in immediately available funds. Payment is considered to have been made when received by the Company.

If the payment due date falls on a Sunday or on a Holiday which is observed on a fonday, the payment due date shall be the first non-Holiday day following such Sunday or Holiday. If the payment due date falls on a Saturday or on a Holiday which is observed on Tuesday, Wednesday, Thursday, or Friday, the payment due date shall be the last non-Holiday day preceding such Saturday or Holiday. If payment is not received by the payment due date, a late payment penalty, as set forth in I. following, shall apply.

- G. Upon proof of tax exempt certification from Alternative Phone, the total amount billed to Alternative Phone will not include any taxes due from the end user. Alternative Phone will be solely responsible for the computation, tracking, reporting and payment of all federal, state and/or local jurisdiction taxes associated with the services resold to the end user.
- H. As the customer of record, Alternative Phone will be responsible for, and remit to the Company, all charges applicable to its resold services for emergency services (E911 and 911) and Telecommunications Relay Service (TRS) as well as any other charges of a similar nature.
- I. If any portion of the payment is received by the Company after the payment due date as set forth preceding, or if any portion of the payment is received by the Company in funds that are not immediately available to the Company, then a late payment penalty shall be due to the Company. The late payment penalty shall be the portion of the payment not received by the payment due date times a late factor. The late factor shall be as set forth in Section A2 of the General Subscriber Service Tariff and Section B2 of the Private Line Service Tariff.

- J. Any switched access charges associated with interexchange carrier access to the resold local exchange lines will be billed by, and due to, the Company. No additional charges are to be assessed to Alternative Phone.
- K. The Company will not perform billing and collection services for Alternative Phone as a result of the execution of this Agreement. All requests for billing services should be referred to the appropriate entity or operational group within the Company.
- L. Pursuant to 47 CFR Section 51.617, the Company will bill Alternative Phone end user common line charges identical to the end user common line charges the Company bills its end users.
- M. In general, the Company will not become involved in disputes between Alternative Phone and Alternative Phone's end user customers over resold services. If a dispute does arise that cannot be settled without the involvement of the Company, Alternative Phone shall contact the designated Service Center for resolution. The Company will make every effort to assist in the resolution of the dispute and will work with Alternative Phone to resolve the matter in as timely a manner as possible. Alternative Phone may be required to submit documentation to substantiate the claim.

VIII. Discontinuance of Service

- A. The procedures for discontinuing service to an end user are as follows:
 - Where possible, the Company will deny service to Alternative Phone's end user on behalf of, and at the request of, Alternative Phone. Upon restoration of the end user's service, restoral charges will apply and will be the responsibility of Alternative Phone.
 - 2. At the request of Alternative Phone, the Company will disconnect a Alternative Phone end user customer.
 - 3. All requests by Alternative Phone for denial or disconnection of an end user for nonpayment must be in writing.
 - Alternative Phone will be made solely responsible for notifying the end user of the proposed disconnection of the service.
 - 5. The Company will continue to process calls made to the Annoyance Call Center and will advise Alternative Phone when it is determined that annoyance calls are originated from one of their end user's locations. The Company shall be indemnified, defended and held harmless by Alternative Phone and/or the end user against any claim, loss or damage arising from providing this information to Alternative Phone. It is the responsibility of Alternative Phone to take the corrective action necessary with its customers who make annoying calls. Failure to do so will result in the Company's disconnecting the end user's service.
- B. The procedures for discontinuing service to Alternative Phone are as follows:

- The Company reserves the right to suspend or terminate service for nonpayment or in the event
 of prohibited, unlawful or improper use of the facilities or service, abuse of the facilities, or any
 other violation or noncompliance by Alternative Phone of the rules and regulations of the
 Company's Tariffs.
- 2. If payment of account is not received by the bill day in the month after the original bill day, the Company may provide written notice to Alternative Phone, that additional applications for service will be refused and that any pending orders for service will not be completed if payment is not received by the fifteenth day following the date of the notice. If the Company does not refuse additional applications for service on the date specified in the notice, and Alternative Phone's noncompliance continues, nothing contained herein shall preclude the Company's right to refuse additional applications for service without further notice.
- If payment of account is not received, or arrangements made, by the bill day in the second
 consecutive month, the account will be considered in default and will be subject to denial or
 disconnection, or both.
- 4. If Alternative Phone fails to comply with the provisions of this Agreement, including any payments to be made by it on the dates and times herein specified, the Company may, on thirty days written notice to the person designated by Alternative Phone to receive notices of noncompliance, discontinue the provision of existing services to Alternative Phone at any time thereafter. In the case of such discontinuance, all billed charges, as well as applicable termination charges, shall become due. If the Company does not discontinue the provision of the services involved on the date specified in the thirty days notice, and Alternative Phone's noncompliance continues, nothing contained herein shall preclude the Company's right to discontinue the provision of the services to Alternative Phone without further notice.
- 5. If payment is not received or arrangements made for payment by the date given in the written notification, Alternative Phone's services will be discontinued. Upon discontinuance of service on a Alternative Phone's account, service to Alternative Phone's end users will be denied. The Company will also reestablish service at the request of the end user or Alternative Phone upon payment of the appropriate connection fee and subject to the Company's normal application procedures. Alternative Phone is solely responsible for notifying the end user of the proposed disconnection of the service.
- If within fifteen days after an end user's service has been denied no contact has been made in reference to restoring service, the end user's service will be disconnected.

DL Liability

A. The liability of the Company for damages arising out of mistakes, omissions, interruptions, preemptions, delays errors or defects in transmission, or failures or defects in facilities furnished by the Company, occurring in the course of furnishing service or other facilities and not caused by the negligence of Alternative Phone, or of the Company in failing to maintain proper standards of maintenance and operation and to exercise reasonable supervision shall in no event exceed an amount equivalent 40 the proportionate

charge to Alternative Phone for the period of service during which such mistake, omission, interruption, preemption, delay, error or defect in transmission or defect or failure in facilities occur. The Company shall not be liable for damage arising out of mistakes, omission, interruptions, preemptions, delays, errors or defects in transmission or other injury, including but not limited to injuries to persons or property from voltages or currents transmitted over the service of the Company, (1) caused by customer-provided equipment (except where a contributing cause is the malfunctioning of a Company-provided connecting arrangement, in which event the liability of the Company shall not exceed an amount equal to a proportional amount of the Company billing for the period of service during which such mistake, omission, interruption, preemption, delay, error, defect in transmission or injury occurs), or (2) not prevented by customer-provided equipment but which would have been prevented had Company-provided equipment been used.

- B. The Company shall be indemnified and saved harmless by Alternative Phone against any and all claims, actions, causes of action, damages, liabilities, or demands (including the costs, expenses and reasonable attorneys' fees, on account thereof) of whatever kind or nature that may be made by any third party as a result of the Company's furnishing of service to Alternative Phone.
- C. The Company shall be indemnified, defended and held harmless by Alternative Phone and/or the end user against any claim, loss or damage arising from the use of services offered for resale involving:
 - 1. Claims for libel, slander, invasion of privacy or infringement of copyright arising from Alternative Phone's or end user's own communications.
 - Claims for patent infringement arising from acts combining or using Company services in connection with facilities or equipment furnished by the end user or Alternative Phone.
 - 3. All other claims arising out of an act or omission of Alternative Phone or its end user in the course of using services.
- D. Alternative Phone accepts responsibility for providing access for maintenance purposes of any service resold under the provisions of this Tariff. The Company shall not be responsible for any failure on the part of Alternative Phone with respect to any end user of Alternative Phone.

X. Treatment of Proprietary and Confidential Information

A. Both parties agree that it may be necessary to provide each other during the term of this Agreement with certain confidential information, including trade secret information, including but not limited to, technical and business plans, technical information, proposals, specifications, drawings, procedures, customer account data and like information (hereinafter collectively referred to as "Information"). Both parties agree that all Information shall either be in writing or other tangible format and clearly marked with a confidential, private or proprietary legend, or, when the Information is communicated orally, it shall also be communicated that the Information is confidential, private or proprietary. Both parties agree to receive such Information and not disclose such Information. Both parties agree to protect the Information received from distribution, disclosure or dissemination to anyone except employees of the parties with a need to know such Information and which employees agree to be bound by the terms of
