AMENDATORY ORDER

On March 9, 1998, the Commission issued Order No. PSC-98-0374-FOF-EG, in Docket No. 970540-EG, granting Florida Power & Light Company's motion to dismiss the Florida Apartment Association's protest of our Proposed Agency Action Order No. PSC-97-1480-FOF-EG (PAA Order) and making the PAA Order final and effective. After issuance, a scrivener's error was noted. To correct this error, Order No. PSC-98-0374-FOF-EG is amended as follows:


1. On page 9, the phrase "It is further" will be added to the end of the second ordering paragraph.
