BY THE COMMISSION:

American Communication Services of Jacksonville, Inc. (ACSI of Jacksonville) is the holder of Alternative Local Exchange Telecommunications (ALEC) Certificate of Public Convenience and Necessity No. 4722. ACSI Local Switched Services, Inc. (ACSI) is the holder of ALEC Certificate of Public Convenience and Necessity No. 5474 and Interexchange Telecommunications (IXC) Certificate of Public Convenience and Necessity No. 5339.

By letter dated April 14, 1998, ACSI of Jacksonville and ACSI requested that their certificates be amended to reflect the inclusion of a fictitious name, d/b/a e. spire Communications, Inc. Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by American Communication Services of Jacksonville, Inc. to change the name on Certificate No. 4722 from American Communication Services of Jacksonville, Inc. to American Communication Services of Jacksonville, Inc. d/b/a e. spire Communications, Inc. is hereby approved. It is further

ORDERED that the request by ACSI Local Switched Services, Inc. to change the name on Certificate No. 5474 and Certificate No. 5339 from ACSI Local Switched Services, Inc. to ACSI Local Switched Services, Inc. d/b/a e. spire Communications, Inc. is hereby approved. It is further



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
