# ORDER APPROVING RESALE AGREEMENT

# BY THE COMMISSION:

On February 6, 1998, BellSouth Telecommunications, Inc., (BellSouth) and Buy-Tel Communications, Inc., (Buy-Tel) filed a request for approval of a resale agreement under the Telecommunications Act of 1996, 47 U.S.C. \$252(e) of the Telecommunications Act of 1996 (the Act). The agreement is attached to this Order as Attachment A and incorporated by reference herein.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission r it shall be deemed approved.

This agreement covers a two-year period and governs the relationship between the companies regarding the resale of tariffed telecommunication services. Under 47 U.S.C. § 252(a)(1), the agreement shall include a detailed schedule of itemized charges for

interconnection and each service or network element included in the agreement. The agreement states that telecommunications services provided by BellSouth for resale will be available for purchase by Buy-Tel at a discount rate of 21.83% for residential services and 16.81% for business services.

Upon review of the proposed agreement, we find that it complies with the Telecommunications Act of 1996; thus, we hereby approve it. BellSouth and Buy-Tel must file any supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

We note that Buy-Tel does not currently hold a Florida certificate to provide alternative local exchange telecommunications services, and therefore, it cannot provide alternative local exchange telecommunications services under this agreement until it obtains a certificate from this Commission.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the resale agreement between BellSouth Telecommunications, Inc., and Buy-Tel Communications, Inc., as set forth in Attachment A and incorporated by reference in this Order, is hereby approved. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that Buy-Tel Communications, Inc., shall not provide alternative local exchange telecommunications services under this agreement until it obtains a certificate to provide alternative local exchange telecommunications services from this Commission. It is further

# NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

Agreement Between BellSouth Telecommunications, Inc. and Buy-Tel Communications, Inc., Inc. Regarding The Sale of BellSouth Telecommunications Services to Buy-Tel Communications, Inc., Inc. For The Purposes of Resale

THIS AGREEMENT is by and between Bellfouth Telecommunications, Inc., ("BellSouth" or "Company"), a Georgia corporation, and Buy-Tel Communications, Inc., Inc., ("Buy-Tel"), a Texas corporation, and shall be deemed effective as of January 26, 1998.

#### WITNESSETH

WHEREAS, BellSouth is a local exchange telecommunications company authorized to provide telecommunications services in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tenassest; and

WHEREAS, Buy-Tel is or seeks to become an alternative local exchange telecommunications company authorized to provide telecommunications services in the states of Alabama, Florida, Georgia, Kautucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee; and

WHEREAS, Buy-Tel desires to reself BellSouth's telecommunications services; and

WHEREAS, Belificuits has agreed to provide such services to Buy-Tel for resale purposes and pursuant to the terms and conditions set forth herein:

NOW, THEREFORE, for and in consideration of the status premises and promises contained herein. BellSouth and Buy-Tel do hereby agree as follows:

## L. Term of the Agreement

- A. The term of this Agreement shall be two years beginning January 26, 1998 and shall apply to all of BellSouth's serving territory as of January 1, 1998 in the stress of Alabama, Florida, Georgia, Kentucky, Louisiana, Missianippi, North Carolina, South Carolina, and Tennesses; and
- B. This Agreement shall be automatically renowed for two additional one year periods unless either party indicates its intent not to renow the Agreement. Notice of such intent must be provided, in writing, to the other party no later than 60 days prior to the and of the then-existing contract period. The terms of this Agreement shall remain in effect after the term of the existing agreement has expired and while a new agreement is being negotiated.

The rates pursuant by which Buy-Tel is to purchase services from BellSouth for resale shall be at a discount rate off of the retail rate for the telecommunications service. The discount rates shall be as set forth in Exhibit A, ettached hereto and incorporated herein by this reference. Such discount shall reflect the costs avoided by BellSouth when selling a service for wholesale purposes.

## II. Definition of Torms

- A. CUSTOMER OF RECORD means the eatity responsible for placing application for service; requesting additions, rearrangements, maintenance or discontinuance of service; payment in full of charges incurred such as non-recurring, monthly recurring, toll, directory sesistance, etc.
- B. DEPOSIT means assurance provided by a customer in the form of cash, surety bond or bank letter of credit to be held by the Company.

- C. END USER means the ultimate user of the telecommunications services.
- D. END USER CUSTOMER LOCATION means the physical location of the premises where an end user makes use of the reiccommunications services.
- E. NEW SERVICES means functions, features or capabilities that are not currently offered by BeilSouth. This includes packaging of existing services or combining a new function, feature or capability with an existing service.
- F. OTHER LOCAL EXCHANGE COMPANY (OLEC) means a selephone company certificated by the public service commissions of the Company's frunchised area to provide local exchange service within the Company's frunchised area.
- G. RESALE means an activity wherein a certificated OLEC, such as Buy-Tel subscribes to the telecommunications services of the Company and then reoffers those telecommunications services to the public (with or without "adding value").
- H. RESALE SERVICE AREA means the area, as defined in a public service commission approved certificate of operation, within which as OLEC, such as Buy-Tel, may offer resold local exchange telecommunications service.

#### **III. General Provisions**

A. Buy-Tel may recall the tarified local exchange and tell telecommunications services of BallSouth contained in the General Subscriber Service Tariff and Private Line Service Tariff subject to the terms, and conditions specifically set forth herein. Notwithstanding the foregoing, the exclusion and limitations on services available for recals will be as set forth in Exhibit B, standard hereto and incorporated herein by this reference.

BellSouth shall make available telecommunications services for resals at the rates set forth in Exhibit A to this agreement and subject to the exclusions and limitations set forth in Exhibit B to this agreement. It does not however waive its rights to appeal or otherwise challenge any decision regarding resals that resulted in the discount rates contained in Exhibit A or the exclusions and limitations contained in Exhibit B. BellSouth reserves the right to pursue any and all legal and/or equitable remedies, including appeals of any decisions. If such appeals or challenges result in changes in the discount rates or exclusions and limitations, the parties agree that appropriate modifications to this Agreement will be made promptly to make its terms consistent with the outcome of the appeal.

- B. Buy-Tel may purchase resale services from BellSouth for their own use in operating their business. The resale discount will apply to those services under the following conditions:
  - 1. Buy-Tel must recall services to other end users.
  - Buy-Tel must order services through resule interfaces, i. e., the LCSC and/or appropriate Resule Account Teams.
  - Buy-Tel cannot be an alternative local exchange telecommunications company for the single purpose of selling to themselves.
- C. The provision of services by the Company to Buy-Tel does not constitute a joint undertaking for the furnishing of any service.

- D. Buy-Tel will be the customer of record for all services purchased from BellSouth. Except as specified herein, the Company will take orders from, bill and expect payment from Buy-Tel for all services.
- E. Buy-Tel will be the Company's single point of contact for all services purchased pursuant to this Agreement. The Company shell have no contact with the end user except to the extent provided for herein.
- F. The Company will continue to bill the end user for any services that the end user specifies it wishes to receive directly from the Company.
- G. The Company maintains the right to serve directly any and user within the service area of Buy-Tel. The Company will continue to directly market its own telecommunications products and services and in doing so may establish independent relationships with end users of Buy-Tel.
- H. Neither Perty shall interfere with the right of any person or entity to obtain service directly from the other Perty.
- L. Current telephone numbers any normally be retained by the end user. However, telephone numbers are the property of the Company and are assigned to the service furnished. Buy-Tel has no property right to the telephone number or any other cell number designation associated with services furnished by the Company, and no right to the continuance of service through any particular control office. The Company reserves the right to change such numbers, or the central office designation associated with such numbers, or both, whenever the Company downs it necessary to do so in the conduct of its business.
- J. The Company may provide any service or facility for which a charge is not established herein, as long as it is offered on the same terms to Sky-Tel.
- K. Service is furnished subject to the condition that it will not be used for any unlawful purpose.
- L. Service will be discontinued if any law enforcement agency advises that the service being used is in violation of the law.
- M. The Company can refuse service when it has grounds to believe that service will be used in violation of the law.
- N. The Company accepts no responsibility to any person for any unlawful act committed by Buy-Tel or its end users as part of providing service to Buy-Tel for purposes of resals or otherwise.
- O. The Company will cooperate fully with law enforcement agencies with subposees and court orders for assistance with the Company's customers. Law enforcement agency subposees and court orders regarding end users of Buy-Tel will be directed to Buy-Tel. The Company will bill Buy-Tel for implementing any requests by law enforcement agencies regarding Buy-Tel and users.
- P. The characteristics end methods of operation of any circuits, facilities or equipment provided by any person or entity other than the Company shall not:
  - Interfere with or impair service over any facilities of the Company, its affiliates, or its connecting and concurring carriers involved as its service;
  - 2. Cause damage to their plant;
  - 3. Impeir the privacy of any communications; or

- 4. Create hazards to any employees or the public.
- Q. Buy-Tel assumes the responsibility of notifying the Company regarding less than standard operations with respect to services provided by Buy-Tel.
- R. Facilities and/or equipment utilized by BellSouth to provide service to Buy-Tel remain the property of BellSouth.
- S. White page directory listings will be provided in accordance with regulations set forth in Section A6 of the General Subscriber Service Teriff and will be available for resale.
- T. BellSouth will provide customer record information to Buy-Tel provided Buy-Tel has the appropriate Lener(s) of Authorization. BellSouth may provide customer record information via one of the following methods: US mail, flux, or by electronic interface. BellSouth will provide customer record information via US mail or flux on an interface basis only.
  - Buy-Tel agrees to compensate BellSouth for all BellSouth incurred expenditures associated with providing such information to Buy-Tel. Buy-Tel will adopt and adhere to the BellSouth guidelines associated with each method of providing customer record information.
  - All costs incurred by BellSouth to develop and implement operational interfaces shall be recovered from Buy-Tel.
- U. BellSouth will provide certain selected messaging services to Buy-Tel for resals of messaging service without the wholesals discount.
- V. BellSouth's Inside Wire Maintenance Plans may be made available for resale at rates, terms and conditions as set forth by BellSouth and without the wholesale discount.
- W. All costs incurred by BellSouth for providing services to Buy-Tel that are not covered in the BellSouth tariffs shall be recovered from the Buy-Tel(s) who utilize those services.

# IV. BellSouth's Provision of Services to Buy-Tel

- A. Buy-Tel agrees that its resals of BollSouth services shall be as follows:
  - The resale of telecommunications services shall be limited to users and uses conforming to the class of service restrictions.
  - 2. To the extent Buy-Tel is a telecommunications carrier that serves greater than 5 percent of the Nation's presubscribed access lines, Buy-Tel shall not jointly market its interLATA services with the telecommunications services purchased from BellSouth pursuant to this Agreement in any of the states covered under this Agreement. For the purposes of this subsection, to jointly market means any advertisement, marketing effort or billing in which the telecommunications services purchased from BellSouth for purposes of resale to customers and interLATA services offered by Buy-Tel are packaged, tind, bundled, discounted or offered together in any way to the end user. Such efforts include, but are not limited to, sales referrale, resale arrangements, sales agencies or billing agreements. This subsection shall be vaid and of no offer for a particular state covered under this Agreement as of February 8, 1999 or on the date BellSouth is authorized to offer interLATA services in that state, whichever is earlier.
  - Hotel and Hospital PBX service are the only telecommunications services available for resale to Hotel/Motel and Hospital and users, respectively. Similarly, Access Line Service for Customer

Provided Coin Telephones is the only local service available for resale to Independent Payphone Provider (IPP) customers. Shared Tenant Service customers can only be sold those telecommunications services available in the Company's A23 Shared Tenant Service Tariff.

- 4. Buy-Tel is prohibited from furnishing both flat and measured rate service on the same business premises to the same subscribers (and users) as stated in A2 of the Company's Tarit' except for backup service as indicated in the applicable state tariff Section A3.
- 5. If telephone service is established and it is subsequently determined that the class of service restriction has been violated, Buy-Tel will be notified and billing for that service will be immediately changed to the appropriate class of service. Service charges for changes between class of service, back billing, and interest as described in this subsection shall apply at the Company's sole discretion. Interest at a rate as set forth in Section A2 of the General Subscriber Service Tariff and Section B2 of the Private Line Service Tariff for the applicable state, companded daily for the number of days from the back billing date to and including the date that Buy-Tel actually makes the payment to the Company may be assessed.
- 6. The Company reserves the right to periodically sudit services purchased by Buy-Tei to combitate authenticity of use. Such sudit shall not occur more than once in a calendar year. Buy-Tei shall make any and all records and data available to the Company or the Company's auditors on a resecuable basis. The Company shall bear the cost of said sudit.
- 8. Resold services can only be used in the same enumer as specified in the Company's Tariff. Resold services are subject to the same terms and conditions as are specified for such services when furnished to an individual end user of the Company in the appropriate section of the Company's Tariffs. Specific teriff features, e.g. a usage allowance per month, that not be aggregated across multiple resold services. Resold services cannot be used to aggregate traffic from more than one end user customer except as specified in Section A23. of the Company's Tariff referring to Shared Tenant Service.
- C. Buy-Tel may resell services only within the specific resale service area as defined in its certificate.
- D. Telephone numbers transmitted via any resold service feature are intended solely for the use of the end user of the feature. Receive of this information is prohibited.
- E. No patent, copyright, trademark or other proprietary right is liceused, granted or otherwise transferred by this Agreement. Buy-Tel is strictly prohibited from any use, including but not limited to sales, marketing or advertising, of any BellSouth name or trademark.

# V. Maintenance of Services

- A. Buy-Tel will adopt and adhere to the standards contained in the applicable BellSouth Work Center Interface Agreement regarding majoranese and installation of service.
- B. Services resold under the Company's Tariffs and facilities and equipment provided by the Company shall be maintained by the Company.
- C. Buy-Tel or its end users may not rearrange, move, disconnect, remove or attempt to repair any facilities owned by the Company, other than by connection or disconnection to any interface means used, except with the written consent of the Company.
- D. Buy-Tel accepts responsibility to notify the Company of sinutiens that arise that may result in a service problem.

- E. Buy-Tel will be the Company's single point of contact for all repair calls on behalf of Buy-Tel's end users. The parties agree to provide one another with toil-free contact numbers for such purposes.
- F. Buy-Tel will contact the appropriate repair centers in accordance with procedures established by the Company.
- G. For all repair requests, Buy-Tel accepts responsibility for adhering to the Company's prescreening guidelines prior to referring the trouble to the Company.
- H. The Company will bill Buy-Tel for handling troubles that are found not to be in the Company's network pursuant to its standard time and material charges. The standard time and material charges will be no more than what BellSouth charges to its retail customers for the same services.
- I. The Company reserves the right to content Buy-Tel's customers, if deemed necessary, for maintenance purposes.

### VI. Establishment of Service

- A. After receiving certification as a local exchange company from the appropriate regulatory agency, Buy-Tel will provide the appropriate Company service center the necessary documentation to enable the Company to establish a master account for Buy-Tel. Such documentation shall include the Application for Master Account, proof of authority to provide telecommunications services, as Operating Company Number ("OCN") assigned by the National Exchange Carriers Association ("NECA") and a tax exemption certificate, if applicable. When necessary deposit requirements are met, the Company will begin taking orders for the receive of service.
- B. Service orders will be in a standard format designated by the Company.
- C. When notification is received from Buy-Tel that a current customer of the Company will subscribe to Buy-Tel's service, standard service order intervals for the appropriate class of service will apply.
- D. The Company will not require and user confirmation prior to establishing service for Buy-Tel's end user customer. Buy-Tel must, however, be able to demonstrate and user authorization upon request.
- E. Buy-Tel will be the single point of content with the Company for all subsequent ordering activity resulting in additions or changes to resold services except that the Company will accept a request directly from the end user for conversion of the end user's service from Buy-Tel to the Company or will accept a request from another OLEC for conversion of the end user's service from Buy-Tel to the other LEC. The Company will notify Buy-Tel that such a request has been processed.
- F. If the Company determines that an unauthorized change is local service to Buy-Tel has occurred, the Company will resetablish service with the appropriate local service provider and will assess Buy-Tel as the OLEC initiating the unauthorized change, the unauthorized change charge described in F.C.C. Tariff No. 1, Section 13. Appropriate nearecurring charges, as set forth in Section A4. of the General Subscriber Service Tariff, will also be assessed to Buy-Tel. These charges can be adjusted if Buy-Tel provides satisfactory proof of authorization.
- G. In order to safeguard its interest, the Company reserves the right to secure the account with a suimble form of security deposit, unless satisfactory credit has already been established.
  - Such security deposit shall take the form of an irrevocable Letter of Credit or other forms of security acceptable to the Company. Any such security deposit may be held during the

continuance of the service as security for the payment of any and all amounts accruing for the service.

- If a security deposit is required, such security deposit shall be made prior to the unauguration of service.
- 3. Such security deposit may not exceed two months' estimated billing.
- 4. The fact that a security deposit has been made in no way relieves Buy-Tel from complying with the Company's regulations as to advance payments and the prompt payment of bills on presentation nor does it constitute a waiver or modification of the regular practices of the Company providing for the discontinuance of service for non-payment of any sums due the Company.
- The Company reserves the right to increase the security deposit requirements when, in its sole
  judgment, circumstances so werrant and/or gross monthly billing has increased beyond the level
  initially used to determine the security deposit.
- In the event that Buy-Tel definite on its account, service to Buy-Tel will be terminated and any security deposits held will be applied to its account.
- 7. In the case of a cash deposit, interest at a rate as set forth in the appropriate BellSouth tariff shall be paid to Buy-Tel during the continuance of the SCCurity deposit. Interest on a SCCurity deposit shall occur annually and, if requested, shall be annually credited to Buy-Tel by the accrual date.

# VII. Payment And Billing Arrangements

- A. When the initial service is ordered by Buy-Tel, the Company will establish an accounts receivable master account for Buy-Tel.
- B. The Company shall bill Buy-Tel on a current basis all applicable charges and credits.
- C. Payment of all charges will be the responsibility of Buy-Tel. Buy-Tel shall make payment to the Company for all services billed. The Company is not responsible for payments not received by Buy-Tel from Buy-Tel's customer. The Company will not become involved in billing disputes that may arise between Buy-Tel and its customer. Payments made to the Company as payment on account will be credited to an account receivable matter account and not to an end user's account.
- D. The Company will reader bills each month on established bill days for each of Buy-Tel's accounts.
- E. The Company will bill Buy-Tel, in advance, charges for all services to be provided during the ensuing billing period except charges associated with service usage, which charges will be billed in arrears. Charges will be calculated an an individual end user account level, including, if applicable, any charges for usage or usage allowances. BellSouth will also bill all charges, including but not limited to 911 and E911 charges, telecommunications relay charges, and franchise floss, to Buy-Tel.
- F. The payment will be due by the sext bill date (i.e., same date in the following mouth as the bill date) and is payable in immediately available funds. Payment is considered to have been made when received by the Company.
  - If the payment due date falls on a Sendey or on a Holiday which is observed on a Monday, the
    payment due date shall be the first non-Holiday day following such Sunday or Holiday. If the
    payment due date falls on a Samrday or on a Holiday which is observed on Tuesday, Wednesday.

Thursday, or Friday, the payment due date shall be the last non-Holiday day preceding such Saturday or Holiday. If payment is not received by the payment due date, a late payment penalty, as set forth in I. following, shall apply.

- G. Upon proof of tax exempt certification from Buy-Tel, the total amount billed to Buy-Tel will not include any taxes due from the end user. Buy-Tel will be solely responsible for the computation, tracking, reporting and payment of all federal, state and/or local jurisdiction taxes associated with the services resold to the end user.
- H. As the customer of record, Buy-Tel will be responsible for, and remit to the Company, all charges applicable to its resold services for emergency services (E911 and 911) and Telecommunications Relay Service (TRS) as well as any other charges of a signifer nature.
- If any portion of the payment is received by the Company after the payment due date as set forth preceding, or if any portion of the payment is received by the Company in funds that are not immediately available to the Company, then a late payment penalty shall be due to the Company. The late payment penalty shall be the pertion of the payment not received by the payment due date times a late factor. The late factor shall be as set forth in Section A2 of the General Subscriber Service Tartiff and Section B2 of the Private Line Service Tartiff.
- J. Any switched access charges associated with interexchange carrier access to the resold local exchange lines will be billed by, end due to, the Company. No additional charges are to be assessed to Buy-Tel.
- K. The Company will not perform billing and collection services for Buy-Tel as a result of the execution of this Agreement. All requests for billing services should be referred to the appropriate entity or operational group within the Company.
- L. Pursuant to 47 CFR Section 51.617, the Company will bill Buy-Tel end user common line charges identical to the end user common line charges the Company bills its end users.
- M. In general, the Company will not become involved in disputes between Buy-Tel and Buy-Tel's end user customers over resold services. If a dispute does arise that cannot be settled without the involvement of the Company, Buy-Tel shell contact the designated Service Center for resolution. The Company will make every effort to assist in the resolution of the dispute and will work with Buy-Tel to resolve the matter in as timely a manner as possible. Buy-Tel may be required to submit documentation to substantiate the claim.

# VIII. Discontinuance of Service

- A. The procedures for discontinuing service to an end user are as follows:
  - Where possible, the Company will deny service to Buy-Tel's end user on behelf of, and at the request of, Buy-Tel. Upon restoration of the end user's service, restoral charges will apply and will be the responsibility of Buy-Tel.
  - 2. At the request of Buy-Tel, the Company will disconnect a Buy-Tel and user customer.
  - All requests by Buy-Tet for denial or disconnection of an end user for nonpsyment must be in writing.
  - Buy-Tel will be made solely responsible for notifying the end user of the proposed disconnection
    of the service.

5. The Company will continue to process calls made to the Annoyance Call Center and will advise Buy-Tel when it is determined that annoyance calls are originated from one of their end user's locations. The Company shall be indemnified, defended and held harmless by Buy-Tel and/or the end user against any claim, loss or damage arising from providing this information to Buy-Tel. It is the responsibility of Buy-Tel to take the corrective action necessary with its customers who make annoying calls. Failure to do so will result in the Company's disconnecting the end user's service.

# B. The procedures for discontinuing service to Buy-Tel are as follows:

- The Company reserves the right to suspend or terminate service for nonpeyment or in the event of prohibited, unlawful or improper use of the facilities or service, abuse of the facilities, or any other violation or noncompliance by Buy-Tel of the rules and regulations of the Company's Tariffi.
- 2. If payment of account is not received by the bill day in the month after the original bill day, the Company may provide written notice to Buy-Tei, that additional applications for service will be refused and that any pending orders for service will not be completed if payment is not received by the fifteenth day following the date of the notice. If the Company does not refuse additional applications for service on the date specified in the notice, and Buy-Tel's noncompliance continues, nothing commined herein shall practice the Company's right to refuse additional applications for service without further notice.
- If payment of account is not received, or arrangements made, by the bill day in the second
  consecutive month, the account will be considered in default and will be subject to denial or
  disconnection, or both.
- 4. If Buy-Tel fails to comply with the provisions of this Agreement, including any payments to be made by it on the dates and times herein specified, the Company may, on thirty days written notice to the person designated by Buy-Tel to receive notices of noncompliance, discontinue the provision of existing services to Buy-Tel at any time thereafter. In the case of such discontinuence, all billed charges, as well as applicable termination charges, shall become due. If the Company does not discontinue the provision of the services involved on the date specified in the thirty days notice, and Buy-Tel's noncompliance continues, nothing contained herein shall preclude the Company's right to discontinue the provision of the services to Buy-Tel without further notice.
- 5. If payment is not received or arrangements made for payment by the date given in the written notification, Buy-Tel's services will be discontinued. Upon discontinuence of service on a Buy-Tel's account, service to Buy-Tel's end users will be denied. The Company will also reestablish service at the request of the end user or Buy-Tel upon payment of the appropriate connection for and subject to the Company's normal application procedures. Buy-Tel is solely responsible for notifying the and user of the proposed disconnection of the service.
- If within fifteen days after an end user's service has been dealed no context has been made in reference to restoring service, the and user's service will be disconnected.

IX. Liability

- A. The liability of the Company for demages arising out of mistakes, omissions, interruptions, preemptions. delays arrors or defects in transmission, or failures or defects in facilities furnished by the Company. occurring in the course of famishing service or other facilities and not course by the negligence of Buy-Tel, or of the Company in falling to maintain proper standards of maintenance and operation and to exercise reasonable supervision shall in no event exceed an amount equivalent to the proportionase charge to Buy-Tel for the period of service during which such mistake, one insign, interruption, preemption, delay, error or defect in transmission or defect or failure in facilities occur. The Company shall not be liable for demage arising out of mistakes, omission, interruptions, preemptions, delays, errors or defects in transmission or other injury, including but not limited to injuries to persons or property from voltages or currents transmitted over the service of the Company, (1) caused by customer-provided equipment (except where a contributing cause is the maifunctioning of a Company-provided connecting arrangement, in which event the liability of the Company shall not exceed an amount equal to a proportional amount of the Company billing for the period of service during which such mistake. omission, interruption, preemption, delay, error, defect in transmission or injury occurs), or (2) not prevented by customer-provided equipment but which would have been prevented had Companyprovided equipment been used.
- B. The Company shall be indemnified and seved harmless by Buy-Tel against any and all claims, actions, causes of action, damages, liabilities, or demands (including the costs, expenses and reasonable attorneys' fees, on account thereof) of whatever kind or eather that may be made by any third party as a result of the Company's furnishing of service to Buy-Tel.
- C. The Company shall be indomnified, defended and held harmless by Buy-Tel and/or the end user against any claim, loss or damage grising from the use of services offered for reads involving:
  - Claims for libel, stander, investor of privacy or infringement of copyright arising from Buy-Tel's
    or and user's own communications.
  - Claims for patent infringement arising from acts combining or using Company services in connection with facilities or equipment furnished by the and user or Buy-Tel.
  - All other claims arising out of an act or omission of Buy-Tel or its end user in the course of using services.
- D. Buy-Tel accepts responsibility for providing access for maintenance purposes of any service resold under the provisions of this Tariff. The Company shall not be responsible for any failure on the part of Buy-Tel with respect to any and user of Buy-Tel.

# X. Treatment of Proprietary and Confidential Information

A. Both parties agree that it may be necessary to provide each other during the term of this Agreement with certain confidential information, including trade secret information, including but not limited to, technical and business plans, technical information, proposals, specifications, drawings, procedures, customer account data and illio information (hereinafter collectively referred to as "information."). Both parties agree that all information shall either be in writing or other tangible format and clearly marked with a confidential, private or proprietary legend, or, when the information is communicated orally, it shall also be communicated that the information is confidential, private or proprietary. The information will be returned to the owner within a reasonable time. Both parties agree that the information shall not be copied or reproduced in any form. Both parties agree to receive such information and not disclose such information. Both parties agree to protect the information received from distribution, disclosure or dissemination to anyone except employees of the parties with a need to know such information and which employees agree to be bound by the terms of this Section. Both parties will use the same standard

of care to protect Information received as they would use to protect their own confidential and proprietary Information.

B. Notwithstanding the foregoing, both parties agree that there will be no obligation to protect any portion of the Information that is either: 1) made publicly available by the owner of the Information or lawfully disclosed by a nonparty to this Agreement; 2) lawfully obtained from any source other than the owner of the Information; or 3) previously known to the receiving party without an obligation to keep it confidential.

# XI. Resolution of Disputes

Except as otherwise stated in this Agreement, the parties agree that if any dispute arises as to the interpretation of any provision of this Agreement or as to the proper implementation of this Agreement, either Party may position the Commission for a resolution of the dispute. However, each party reserves any rights it may have to seek judicial review of any ruling made by the Commission concerning this Agreement.

## XII. Limitation of Use

The parties agree that this Agreement shall not be proffered by either party in another jurisdiction as evidence of any concession or as a waiver of any position taken by the other party in that jurisdiction or for any other purpose.

## XIII. Walvers

A failure or delay of either Party to enforce any of the provisions hereof, to exercise any option which is berein provided, or to require performance of any of the provisions hereof shall in no way be construed to be a waiver of such provisions or options, and each Party, netwidetending such failure, shall have the right thereofter to insert upon the specific performance of any and all of the provisions of this Agreement.

# XIV. Governing Law

This Agreement shell be governed by, and construed and enforced in accordance with, the laws of the State of Georgia, without regard to its conflict of laws principles.

# XV. Arm's Longth Negotiations

This Agreement was executed after arm's length negetiations between the undersigned parties and reflects the conclusion of the undersigned that this Agreement is in the best interests of all parties.

This Agreement sets forth the entire understanding and supersedes prior agreements between the parties relating to the subject matter contained herein and merges all prior discussions between them, and neither party shall be bound by any definition, condition, provision, representation, warranty, coverant or promise other than as expressly stated in this Agreement or as is contemporaneously or subsequently set forth in writing and executed by a duly authorized officer or representative of the party to be bound thereby.
