(BellSouth). At our agenda conference, Commission staff identified certain corrections to the rates set forth in staff's recommendation. We approved the corrected rates. Due to a scrivener's error, however, one correction was not reflected in our Final Order. Specifically, the \$101.61 rate for DS-1 Facility Termination set forth in Table I, on page 13, is incorrect. The approved rate is \$99.79.

Therefore, Order No. PSC-98-0604-FOF-TP is hereby corrected to accurately reflect the \$99.79 rate that we approved for DS-1 Facility Termination.

Based on the foregoing, it is, therefore,

ORDERED by the Florida Public Service Commission that Order No. PSC-98-0604-FOF-TP is hereby amended to reflect that the rate for DS-1 Facility Termination is \$99.79. It is further

ORDERED that Order No. PSC-98-0604-FOF-TP is affirmed in all other respects.
