ORDER CANCELLING PAY TELEPHONE CERTIFICATE

BY THE COMMISSION:

LPT Services, Inc. (LPT) holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 4511, has requested the cancellation of PATS Certificate No. 4511. LPT has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its PATS certificate and by submitting its regulatory assessment fees for 1997. Accordingly, we find it appropriate to cancel PATS Certificate No. 4511, effective October 19, 1998.

LPT shall return its certificate to this Commission. In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual regulatory assessment fee of \$50 if the certificate was active during any portion of the calendar year. A Regulatory Assessment Fee Return notice for 1998 will be mailed to LPT. Neither the cancellation of its certificate nor the failure to receive a Regulatory Assessment Fee Return notice for the year 1998 shall relieve LPT from its obligation to pay due and owing regulatory assessment fees.



Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
