REVISED ORDER ESTABLISHING PROCEDURE

On August 20, 1998, Telephone Company of Central Florida, Inc. (TCCF), filed a petition for resolution of items under dispute in the resale agreement with BellSouth Telecommunications, Inc. The issues raised in the petition have been separated into issues for enforcement of its current interconnection agreement, and issues for arbitration of the renewal of the resale agreement. The issues raised in TCCF's petition are set for an administrative hearing on January 22, 1999.

This Order is issued pursuant to the authority granted by Rule 28-106.211, Florida Administrative Code, which provides that the presiding officer before whom a case is pending may issue any orders necessary to effectuate discovery, prevent delay, and promote the just, speedy, and inexpensive determination of all aspects of the case.

The scope of this proceeding shall be based upon the issues raised by the parties and Commission staff (staff) up to and during the prehearing conference, unless modified by the Commission. The hearing will be conducted according to the provisions of Chapter 120, Florida Statutes, and all administrative rules applicable to this Commission.

Revision of Prehearing Date

Due to scheduling conflicts, the prehearing in this docket has been moved from January 4, 1999 to January 11, 1999. Order PSC-98-1490-PCO-TP is amended to reflect this schedule change. Order PSC-98-1490-PCO-TP, Order Establishing Procedure, is reaffirmed in all other respects.



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2)
