# ORDER APPROVING AMENDMENT TO EXISTING RESALE AGREEMENT

BY THE COMMISSION:

On November 20, 1998, BellSouth Telecommunications, Inc. (BST) filed a request for approval of an amendment to their existing resale agreement with Annox, Inc. (Annox) under 47 U.S.C. \$252(e) of the Telecommunications Act of 1996. The amendment to the existing agreement is attached to this Order as Attachment A and incorporated by reference herein.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

The existing agreement governs the relationship between the companies regarding the resale of tariffed telecommunication services pursuant to 47 U.S.C. § 251. Upon review of the proposed amendment to the existing agreement, we believe that it complies with the Telecommunications Act of 1996; thus, we hereby approve it. BST and Annox are also required to file any subsequent supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the amendment to the existing resale agreement between BellSouth Telecommunications, Inc. and Annox, Inc., as set forth in Attachment A and incorporated by reference in this Order, is hereby approved. It is further

ORDEPED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this docket shall be closed.

# AMENDMENT TO RESALE AGREEMENT BETWEEN BELLSOUTH TELECOMMUNICATIONS, INC. AND ANNOX, INC. DATED JUNE 11, 1997

Pursuant to this Agreement (the "Amendment"), BellSouth Telecommunications, Inc. ("BellSouth or Company") and Annox, Inc. ("Annox") hereinafter referred to collectively as the "Parties" hereby agree to amend that certain Resale Agreement between the Parties dated June 11, 1997 ("Resale Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BellSouth and Annox hereby covenant and agree as follows:

 The parties hereby agree that Section VIII.A of the Resale Agreement is amended by inserting the following sentence as Subsection 6 at the end of Section VIII.A;

BellSouth may disconnect and rouse facilities when the facility is in a denied state and BellSouth has received an order to establish new service or transfer of service from a customer or a customer's CLEC at the same address served by the denied facility.

- The Parties agree that all of the other provisions of the Resale Agreement, dated June 11, 1997, shall remain in full force and effect.
- The Parties further agree that either or both of the Parties is authorized to submit this Amendment to
  the appropriate Commission or other regulatory body having jurisdiction over the subject matter of this
  Amendment, for approval subject to Section 252(e) of the federal Telecommunications Act of 1996.
