ORDER CANCELING PAY TELEPHONE CERTIFICATE

BY THE COMMISSION:

Andrea Miller (Mrs. Miller) currently holds Certificate of Public Convenience and Necessity No. 5456, issued by the Commission on October 7, 1997, authorizing the provision of pay telephone service (PATS). The Division of Administration advised our staff by memorandum that Mrs. Miller had not paid the regulatory assessment fees (RAFs) required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, for the year 1997, nor statutory penalties and interest charges for late RAFs payments for the year 1997.

Under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was active during any portion of the calendar year. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. All entities that apply for certification receive a copy of our rules governing pay telephone service and an affidavit in which the applicants attest that the rules have been

received and understood by the applicant. This affidavit must be attached to the application in order for the application to be processed. The RAF form was mailed to Mrs. Miller for the period of January 1, 1997, through December 31, 1997. Our correspondence regarding the RAFs was signed for and delivered to Mrs. Miller on December 23, 1997.

On January 29, 1999, Order No. PSC-99-0171-FOF-TC was issued, which imposed a \$500 fine and required payment of the fine and fees. Mrs. Miller has now paid all past due charges and requested voluntary cancellation of her certificate because she is no longer in the pay telephone business. Mrs. Miller has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of her request for cancellation of her PATS certificate and by submitting her regulatory assessment fees for the year 1997. Accordingly, we find it appropriate to cancel PATS Certificate No. 5456, effective December 31, 1998.

Mrs. Miller shall return her certificate to this Commission. In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual regulatory assessment fee of \$50 if the certificate was active during any portion of the calendar year. A Regulatory Assessment Fee Return notice for 1998 has been mailed to Mrs. Miller Neither the cancellation of its certificate nor the failure to receive a Regulatory Assessment Fee Return notice for the year 1998 shall relieve Mrs. Miller from her obligation to pay due and owing regulatory assessment fees.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Andrea Miller's Certificate No. 5456 to provide Pay Telephone services is hereby canceled, effective December 31, 1998. It is further

ORDERED that Andrea Miller shall return her certificate to this Commission and remit all due and owing regulatory assessment fees for the year 1998. It is further

ORDERED that this Docket is closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
