By letter dated February 18, 1999, DIECA Communications, Inc., holder of Alternative Local Exchange Telecommunications Certificate of Public Convenience and Necessity No. 5719, requested that Certificate No. 5719 be amended to reflect the inclusion of a fictitious name, DIECA Communications, Inc. d/b/a Covad Communications Company. Upon review of the Department of State, Division of Corporations' records, it appears that DIECA Communications, Inc. has properly registered the fictitious name. Accordingly, we find it appropriate to amend Certificate No. 5719 to reflect the new operating name.

This Order will serve as DIECA Communications, Inc. d/b/a Covad Communications Company's amended Alternative Local Exchange Telecommunications Certificate of Public Convenience and Necessity No. 5719. 
