AMENDATORY ORDER

BY THE COMMISSION:

On April 2, 1999, we issued Order No. PSC-99-0630-FOF-TP in
the above mentioned Docket. The Order granted approval of a resale
agreement between the above listed entities. Due to a scrivener's
error in the caption and the body of the Order, however, the name
of ACI Corp. d/b/a Accelerated Connections, Inc. was incorrectly
stated as ACI Corporation.

Further, since the issuance of Order No. PSC-99-0630-FOF-TP,
it has come to the Commission's attention that ACI Corp. d/b/a
Accelerated Connections, Inc. is in fact certificated to provide
alternative local exchange telecommunications service in Florida
under Certificate No. 5707.

Therefore, Order No. PSC-99-0630-FOF-TP is amended to
correctly state the name of ACI Corp. d/b/a Accelerated
Connections, Inc. Additionally, the sentence in the body of Order
No. PSC-99-0630-FOF-TP stating that ACI Corp. d/b/a Accelerated
Connections, Inc. is not certificated in Florida and may not
provide service until it receives a certificate shall be deleted.
The ordering paragraph that similarly directs the company to
request and receive a certificate before it provides
telecommunications service shall also be deleted.
