NOTICE OF PROPOSED AGENCY ACTION  
ORDER CANCELLING INTEREXCHANGE  
TELECOMMUNICATIONS AND SHARED TENANT CERTIFICATES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Star National Enterprises, Inc., holder of Interexchange Telecommunications Certificate (IXC) of Public Convenience and Necessity No. 1994 and Shared Tenant Services (STS) Certificate of Public Convenience and Necessity No. 1995, has requested the cancellation of IXC Certificate No. 1994 and STS Certificate No. 1995. Star National Enterprises, Inc. has complied with the provisions of Rule 25-24.474(2), Florida Administrative Code, and Rule 25-24.735(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its IXC certificate and by submitting its Regulatory Assessment Fees (RAFs) for 1998. Accordingly, we find it appropriate to cancel IXC Certificate No. 1994 and STS Certificate No. 1995, effective May 24, 1999.

Star National Enterprises, Inc. shall return its certificates to this Commission. In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee of \$50 if the certificate was active during any portion of the calendar year. A RAF Return notice for 1999 will be mailed to Star National Enterprises, Inc. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice for 1999 shall relieve Star National Enterprises, Inc. from its obligation to pay RAFs for 1999.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Star National Enterprises, Inc.'s Certificate No. 1994 to provide Interexchange Telecommunications services and Certificate No. 1995 to provide Shared Tenant services are hereby canceled, effective May 24, 1999. It is further

ORDERED that Star National Enterprises, Inc. shall return its certificates to this Commission and remit Regulatory Assessment Fees for 1999. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto. It is further

ORDERED that in the event this Order becomes final, this Docket shall be closed.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
