NOTICE OF PROPOSED AGENCY ACTION
ORDER DENYING CERTIFICATE TO PROVIDE ALTERNATIVE LOCAL
EXCHANGE TELECOMMUNICATIONS SERVICE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On December 24, 1998, First Choice Local Communications Inc. (First Choice) filed an application for a Certificate of Public Convenience and Necessity to provide Alternative Local Exchange Telecommunications (ALEC) service. As of the date of this vote, the application lacks the required Secretary of State, Division of Corporations' registration to conduct business in the State of Florida. Therefore, we find that it is not in the public interest to grant a certificate, to provide ALEC service, to First Choice Local Communications Inc.

This petition must be received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on August 13, 1999.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
