AMENDATORY ORDER

BY THE COMMISSION:

On July 13, 1999, we issued Order No. PSC-99-1323-FOF-TP in the above mentioned Docket. The Order granted approval of an amendment to the existing interconnection agreement between the above listed entities. Due to a scrivener's error in the caption and the body of the Order, however, the name of Columbia Telecommunications, Inc. d/b/a axessa was incorrectly stated as Columbia Telecommunications, Inc.

Further, since the issuance of Order No. PSC-99-1323-FOF-TP, it has come to the Commission's attention that Columbia Telecommunications, Inc. d/b/a axessa is in fact certificated to provide Alternative Local Exchange Services in Florida under Certificate No. 4035.

Therefore, Order No. PSC-99-1323-FOF-TP, is amended to correctly state the name of Columbia Telecommunications, Inc. d/b/a axessa. Additionally, the sentence in the body of Order No. PSC-99-1323-FOF-TP stating that Columbia Telecommunications d/b/a axessa is not certificated in Florida and may not provide service until it receives a certificate shall be deleted.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-99-1323-FOF-TP is hereby amended to reflect the name of Columbia Telecommunications, Inc. d/b/a axessa. It is further

ORDERED that the sentence in Order No. PSC-99-1323-FOF-TP stating that Columbia Telecommunications, Inc. d/b/a axessa is not certificated in Florida and may not provide service until it receives a certificate, is hereby deleted. It is further
