NOTICE OF PROPOSED AGENCY ACTION  
ORDER APPROVING MERGER

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated June 24, 1999, Telecom One, Inc. (Telecom One) and Eclipse Telecommunications, Inc. (Eclipse) filed with this Commission an application for approval of merger of Telecom One into Eclipse. Eclipse is the holder of Interexchange

Telecommunications Certificate No. 3178. Telecom One is the holder of Interexchange Telecommunications Certificate No. 3528 and a wholly owned subsidiary of IXC Communications Services, Inc. IXC Communications Services, Inc. is the holder of Interexchange Telecommunications Certificate No. 4031. Telecom One and Eclipse have stated that upon consummation of the merger Telecom One will surrender its Interexchange Telecommunications certificate. The companies have further stated that the transaction will not adversely affect the services being provided to Telecom One's customers because Eclipse will incorporate in its tariff Telecom One's tariffed prices, terms, and conditions presently offered to Telecom One's current customers. Telecom One further stated that it will continue to operate under its existing certificated name on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of Telecom One and Eclipse, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. Our decision does not address the potential impact of the transfer on the competitive market in Florida, or on the companies' or their competitors' interests. We emphasize, however, that our approval of the Petition pursuant to our authority under Section 364.33, Florida Statutes, does not preclude us from addressing any of our concerns that may arise regarding this transaction to the appropriate federal or state agencies.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that Telecom One, Inc. and Eclipse Telecommunications, Inc.'s request for approval of merger of Telecom One, Inc. into Eclipse Telecommunications, Inc. is hereby approved. It is further


ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the
