AMENDATORY ORDER

BY THE COMMISSION:

On December 8, 1999, we issued Order PSC-99-2407-AS-TC. The Order approved the settlement offer by Nationwide Communications, proposing to make a contribution of \$500 and pay the \$0.50 balance from penalties and interest in 1998 with the contribution. However, due to a scrivener's error, in the body of the Order and the ordering paragraphs, the settlement amount was reflected as totaling \$100. Therefore, Order PSC-99-2407-AS-TC is amended to reflect that the correct settlement amount is \$500.50, payable to the Florida Public Service Commission.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-99-2407-AS-TC is hereby amended to reflect that the correct settlement amount is \$500.50, payable to the Florida Public Service Commission. It is further


ORDERED that this Order and Order No. PSC-99-2407-AS-TC, collectively, shall serve as evidence of approval of the settlement offer. It is further
