ORDER ACKNOWLEDGING WITHDRAWAL OF
REQUEST FOR APPROVAL OF AGREEMENT

BY THE COMMISSION:

On July 23, 1999, BellSouth Telecommunications, Inc. (BellSouth) and Communication Service Integrated, Inc. (Communication Service Integrated) filed their negotiated interconnection, unbundling, and resale agreement to be approved by the Florida Public Service Commission. This agreement was approved at the August 17, 1999, Agenda Conference.

On August 19, 1999, prior to the issuance of an Order, BellSouth filed a letter with this Commission asking to withdraw its request for approval of the agreement. The disposition of the request to withdraw was scheduled for the October 5, 1999, Agenda Conference. However, on September 30, 1999, BellSouth asked that the matter be deferred to allow the company additional time to consider amending the agreement.

Thereafter, on November 1, 1999, BellSouth requested withdrawal of the approved agreement. By letter dated November 2,

1999, Communication Service Integrated also requested withdrawal of the approved agreement. Both companies stated that the reason for the request for withdrawal was that Communication Service Integrated had decided not to conduct business within the state of Florida.


For the reasons described above, we find it appropriate to acknowledge the withdrawal of the original filing in this docket, and close this docket.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request for withdrawal of the interconnection, unbundling, and resale agreement between BellSouth Telecommunications, Inc. and Communication Service Integrated, Inc., filed on July 23, 1999, is hereby acknowledged. It is further

ORDERED that this docket shall be closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
