ORDER GRANTING REQUEST FOR
CONFIDENTIAL TREATMENT OF DOCUMENT NOS. 10482-99, 12733-99,
13728-99, and 13725-99

On June 11, 1999, ITC^DeltaCom Communications, Inc. d/b/a ITC^DeltaCom (ITC^DeltaCom) filed a Petition for Arbitration pursuant to 47 U.S.C. 252(b) to arbitrate certain unresolved issues in the interconnection negotiations between ITC^DeltaCom and BellSouth Telecommunications, Inc. (BellSouth). On July 6, 1999, BellSouth filed its response. This matter went to hearing on October 27-29, 1999.

BellSouth filed Requests for Specified Confidential Classification asking that information in specific documents be treated as proprietary confidential business information, in accordance with Section 364.183(3), Florida Statutes, and Rule 25-22.006, Florida Administrative Code. No response was filed.

Florida law presumes that documents submitted to governmental agencies shall be public records. The only exceptions to this presumption are the specific statutory exemptions provided in the law and exemptions granted by governmental agencies pursuant to the specific terms of a statutory provision. This presumption is based on the concept that government should operate in the "sunshine." Rule 25-22.006(4)(c), Florida Administrative Code, provides that it is the Company's burden to demonstrate that the documents fall into one of the statutory examples set out in Section 364.183, Florida Statutes, or to demonstrate that the information is proprietary confidential business information, the disclosure of which will cause the Company or its ratepayers harm.

Section 364.183(3), Florida Statutes, provides:

The term "proprietary confidential business information" means information, regardless of form or characteristics, which is owned or controlled by

the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public.

On September 1, 1999, BellSouth requested that Exhibits DDC-1 and DDC-4 to the direct testimony of D. Daonne Caldwell be given confidential treatment. These Exhibits are in Document No. 10482-99. These Exhibits include information on cost studies and vendor-specific pricing. Attachment A, which is attached and incorporated into this Order, lists the specific lines and columns of each Exhibit which BellSouth deems confidential. BellSouth states that public disclosure of the information would provide its competitors with an unfair advantage, and that the information is not available to its competitors. BellSouth also states that the information is valuable, is used in conducting its business, and that it strives to keep the information confidential. Finally, BellSouth states that it has treated and intends to continue to treat the information as private, and the information has not been generally discussed.

BellSouth revised Exhibit DDC-4 after filing the September 1, 1999, request, and on November 8, 1999, BellSouth requested confidential treatment of the revised Exhibit DDC-4, Document No. 13728-99. Attachment B, which is attached and incorporated into this Order, lists the specific lines and columns of the revised Exhibit which BellSouth deems confidential. The revised Exhibit includes the same type of information as the original Exhibit and BellSouth states it should be treated as confidential for the same reasons.

On October 18, 1999, BellSouth requested that certain items contained in its Responses to Staff's First Set of Interrogatories and Staff's First Request for Production of Documents be given confidential treatment. Specifically, the response to Interrogatory No. 12 and Document No. 3 were the items identified as warranting confidential treatment. Both of these items are contained in Document No. 12733-99. The items include vendor specific and pricing information, and customer specific and cost information. Attachment C, which is attached and incorporated into this Order, lists the specific lines or page numbers of

Interrogatory No. 12 and Document No. 3 that BellSouth deems confidential. BellSouth states that public disclosure of the information would impair BellSouth's ability to contract for goods and services on favorable terms because the documents reveal the cost below which BellSouth cannot provide specific services. BellSouth states it uses this information in conducting its business and strives to keep it secret.

On November 8, 1999, BellSouth requested that certain items contained in its responses to Staff's Second Set of Interrogatories and Second Request for Production of Documents be given confidential treatment. Specifically, the response to Interrogatory No. 42A, and Documents Nos. 12 and 15 were the items identified as warranting confidential treatment. Both of these items are contained in Document No. 13725-99. The responses include information on BellSouth's TAFI system, ADSL Technical Service Description, business forecasts, competitive marketing strategy, and vendor specific prices. Attachment D, which is attached and incorporated into this Order, lists the specific lines of Interrogatory No. 42A, and Documents Nos. 12 and 15 that BellSouth deems confidential. BellSouth states that the information would allow competitors to enhance their systems at BellSouth's expense, and would provide competitors an unfair advantage in future negotiations. BellSouth states it strives to keep this information confidential.

Upon consideration, I believe the information described above satisfies the requirements of Section 364.183(3), Florida Statutes, and Rule 25-22.006, Florida Administrative Code, and should therefore be treated as proprietary confidential business information. BellSouth owns or controls the information and treats the information as private. The public disclosure of the information could cause harm to BellSouth's business operations by impairing its ability contract for goods and services on favorable terms, and by putting BellSouth at a competitive disadvantage.

Based on the foregoing, it is therefore

ORDERED by E. Leon Jacobs, Jr., as Prehearing Officer, that the request by BellSouth Telecommunications, Inc. for confidential



treatment of information in Document Nos. 10482-99, 12733-99, 13728-99, and 13725-99 is granted. It is further

ORDERED that pursuant to Section 364.183, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, any confidentiality granted to the material specified herein shall expire eighteen (18) months from the date of the issuance of this Order, in the absence of a renewed request for confidentiality pursuant to Section 364.183, Florida Statutes. It is further

ORDERED that this Order will be the only notification by the Commission to the parties concerning the expiration of the confidentiality time period.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
