ORDER APPROVING AMENDMENT TO EXISTING
INTERCONNECTION, UNBUNDLING, RESALE, AND COLLOCATION AGREEMENT

BY THE COMMISSION:

On December 10, 1999, GTE Florida Incorporated (GTEFL) and DIECA Communications, Inc. d/b/a Covad Communications Company (Covad Communications) filed a request for approval of an amendment to the existing interconnection, unbundling, resale, and collocation agreement pursuant to 47 U.S.C. §252(e) of the Telecommunications Act of 1996 (the Act). The amendment to the existing agreement is incorporated by reference herein. A copy of the amendment to the existing agreement may be obtained by contacting our Division of Records and Reporting.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

The existing agreement governs the relationship between the companies regarding physical collocation, interconnection, and the resale of tariffed telecommunication services pursuant to 47 U.S.C. § 251. Upon review of the proposed amendment to the existing agreement, we believe that it complies with the Act; thus, we hereby approve it. GTEFL and Covad Communications are also required to file any subsequent supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).


Based on the foregoing, it is
