ORDER APPROVING INTERCONNECTION AGREEMENT

BY THE COMMISSION:

On May 19, 2000, GTE Florida Incorporated (GTEFL) and Maxcess, Inc. (Maxcess) filed, pursuant to 47 U.S.C. §252(e) of the Telecommunications Act of 1996 (the Act), a request for approval of a supplement to their interconnection agreement approved by this Commission by Order No. PSC-00-1123-FOF-TP, issued on June 20, 2000, in Docket No. 000563-TP. The agreement is incorporated by reference herein. A copy of the agreement may be obtained by contacting our Division of Records and Reporting.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

This supplement governs the relationship between the companies regarding physical collocation services under 47 U.S.C. § 251. The supplement states that collocation space will be provided for Maxcess in GTEFL's Central Office.

Upon review of the proposed supplement, we believe that it complies with the Act; thus, we hereby approve it. GTEFL and Maxcess are also required to file any subsequent supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review in Federal district court pursuant to the Federal Telecommunications Act of 1996, 47 U.S.C. § 252(e)(6).
