SECOND ORDER MODIFYING ORDER ESTABLISHING PROCEDURE

On May 26, 2000, MCImetro Access Transmission Services, LLC and MCI WorldCom Communications, Inc. (collectively MCI WorldCom or MCIW) filed a petition for arbitration of certain terms and conditions of a proposed interconnection agreement with BellSouth Telecommunications, Inc. (BellSouth) pursuant to the Telecommunication Act of 1996. On June 20, 2000, BellSouth filed its response to MCI WorldCom's arbitration petition. Pursuant to Order No. PSC-00-1324-PCO-TP, issued July 21, 2000, (Order Establishing Procedure), this matter has been scheduled for an administrative hearing on October 4, 5, and 6, 2000 and controlling dates were established.

Subsequent to the issuance of Order No. PSC-00-1324-PCO-TP, the prehearing conference date required revision to accommodate other scheduling requirements. Accordingly, Order No. PSC-00-1324-PCO-TP, is hereby modified to reflect the following controlling dates.



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
