The entities listed below have complied with the provision of Rule 25-24.474(2), Florida Administrative Code, by providing adequate notice in writing of their request for cancellation of their Interexchange Telecommunications (IXC) certificates and by submitting their Regulatory Assessment Fees (RAFs) for the year 1999. ORDERED that each entity shall return its certificate to this Commission and remit Regulatory Assessment Fees for the year 2000. It is further

ORDERED that any protest to the action proposed herein shall specify the entity or entities to which it applies. It is further


