ORDER CANCELING PAY TELEPHONE CERTIFICATE

BY THE COMMISSION:

James M. Doucett (Doucett), holder of Pay Telephone
Certificate (PATS) of Public Convenience and Necessity No. 6014,
has requested the cancellation of PATS Certificate No. 6014.
Doucett has complied with the provision of Rule 25-24.514(2),
Florida Administrative Code, by providing adequate notice in
writing of his request for cancellation of his PATS certificate and
by submitting his regulatory assessment fees (RAFs) for 1999.
Accordingly, we find it reasonable to cancel PATS Certificate No.
6014, effective September 26, 2000. Doucett shall return his
certificate to this Commission.

In addition, under Section 364.336, Florida Statutes,
certificate holders must pay a minimum annual RAF of \$50 if the
certificate was active during any portion of the calendar year.
Doucett has already submitted his RAFs for 2000.

Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
