AMENDATORY ORDER

BY THE COMMISSION:

On December 22, 2000, we issued Order No. PSC-00-2473-PAA-TI regarding the cancellation of Interexchange Telecommunications Certificate No. 3189 to Home Owners Long Distance Incorporated for violation of Rule 25-4.0161, Florida Administrative Code. On January 5, 2001, Order Number PSC-00-2473A-PAA-TI was issued amending Order No. PSC-00-2473-PAA-TI to correct a scrivener's error in the docket title heading for Docket No. 001213-TI. We subsequently discovered a second scrivener's error in Order No. PSC-2473-PAA-TI which incorrectly lists the years for which Home Owners Long Distance Incorporated has not paid penalties and interest for delinquent regulatory assesement fees (RAFs). Therefore, Order No. PSC-00-2473-PAA-TI is amended to reflect that the years for which penalties and interest on delinquent RAFs have not been paid are 1993, 1994, 1995, 1996, and 1999.



Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-00-2473-PAA-TI is hereby amended to reflect that the years for which Home Owners Long Distance Incorporated has not paid penalties and interest for delinquent regulatory assessment fees are 1993, 1994, 1995, 1996, and 1999. It is further

ORDERED that Orders Nos. PSC-00-2473-PAA-TI and PSC-00-2473A-PAA-TI are reaffirmed in all other respects.
