NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELING INTEREXCHANGE TELECOMMUNICATIONS AND
ALTERNATIVE LOCAL EXCHANGE TELECOMMUNICATIONS CERTIFICATES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

LightNetworks, Inc. (LightNetworks), holder of Interexchange Telecommunications Certificate (IXC) of Public Convenience and Necessity No. 7350 and Alternative Local Exchange Telecommunications Certificate (ALEC) of Public Convenience and Necessity No. 7349, has requested the cancellation of IXC Certificate No. 7350 and ALEC Certificate No. 7349. LightNetworks has complied with the provision of Rule 25-24.474(2) and Rule 25-24.820(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its IXC certificate and ALEC certificate and by submitting its Regulatory Assessment Fees (RAFs) for the years 2000 and 2001. Accordingly, we find it appropriate to cancel IXC Certificate No. 7350 and ALEC

Certificate No. 7349, effective February 20, 2001. LightNetworks shall return to this Commission the Orders granting authority to provide IXC and ALEC services. The Commission is vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing that is available under Section 120.57, Florida Statutes, as well as the procedures and time limits that apply. Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.
