ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated April 3, 2001, SBC National, Inc. d/b/a SBC Telecom, Inc., holder of Interexchange Telecommunications (IXC) Certificate of Public Convenience and Necessity No. 7492 and Alternative Local Exchange Company (ALEC) Certificate of Public Convenience and Necessity No. 7030, requested that Certificate Nos. 7492 and 7030 be amended to reflect the new corporate name, SBC Telecom, Inc. Upon review of the Department of State, Division of Corporations' records, it appears that SBC National, Inc. d/b/a SBC Telecom, Inc. has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate Nos. 7492 and 7030 to reflect the new corporate name.

This Order will serve as the amended IXC and ALEC Certificates of Public Convenience and Necessity No. 7492 and 7030 for SBC Telecom, Inc. SBC Telecom, Inc. should retain this Order as evidence of the name change. The Commission is vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by SBC National, Inc. d/b/a SBC Telecom, Inc. to change the name on Certificate Nos. 7492 and 7030 from SBC National, Inc. d/b/a SBC Telecom, Inc. to SBC Telecom, Inc. is hereby approved. It is further

ORDERED that this Order will serve as SBC Telecom, Inc.'s amended certificates and that this Order should be retained as evidence of the name change. It is further



This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of

this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
