ORDER APPROVING RESALE AGREEMENT AND FIRST AMENDMENT

BY THE COMMISSION:

On March 21, 2001, Sprint-Florida, Incorporated (Sprint-Florida) and Budget Phone, Inc. (Budget Phone) filed a request for approval of a resale agreement and first amendment to the agreement pursuant to 47 U.S.C. §252(e) of the Telecommunications Act of 1996 (the Act). The agreement and the amendment are incorporated by reference herein. A copy of the agreement and its first amendment may be obtained by contacting our Division of Records and Reporting.

The Act encourages parties to enter into negotiated agreements. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

This agreement covers a two-year period and governs the relationship between the companies regarding the resale of tariffed

telecommunications services. Under 47 U.S.C. § 252(a)(1), the agreement shall include a detailed schedule of itemized charges for interconnection and each service or network element included in the agreement. The agreement states that telecommunications services provided by Sprint-Florida for resale will be available for purchase by Budget Phone at varied discount rates.

Upon review of the proposed agreement and its first amendment, we find that both comply with the Act; thus, we hereby approve both. Sprint-Florida and Budget Phone must file any supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).


Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the resale agreement and first amendment to the agreement between Sprint-Florida, Incorporated and Budget Phone, Inc., are incorporated by reference in this Order, and are hereby approved. A copy of the agreement and its first amendment may be obtained as specified in the body of this Order. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this docket shall be closed.

This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review in Federal district court pursuant to the Federal Telecommunications Act of 1996, 47 U.S.C. § 252(e)(6).
