NOTICE OF PROPOSED AGENCY ACTION  
ORDER CANCELLING ALTERNATIVE LOCAL EXCHANGE TELECOMMUNICATIONS  
AND INTEREXCHANGE TELECOMMUNICATIONS CERTIFICATES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Digital Access Communications of Florida, Inc. (Digital Access Communications), holder of Alternative Local Exchange Telecommunications Certificate (ALEC) of Public Convenience and Necessity No. 7771 and Interexchange Telecommunications Certificate (IXC) of Public Convenience and Necessity No. 7772, has requested

the cancellation of ALEC Certificate No. 7771 and IXC Certificate 7772. Digital Access Communications has complied with the provisions of Rules 25-24.820(2) and 25-24.474(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its ALEC and IXC certificates and by submitting its Regulatory Assessment Fees (RAFs) for the years 2000 and 2001. Accordingly, we find it appropriate to cancel ALEC Certificate No. 7771 and IXC Certificate No. 7772, effective May 30, 2001. Digital Access Communications shall return to this Commission the Orders granting authority to provide ALEC services and IXC services.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Digital Access Communications of Florida, Inc.'s Certificate No. 7771 to provide Alternative Local Exchange Telecommunications services is hereby canceled, effective May 30, 2001. It is further

ORDERED that Digital Access Communications of Florida, Inc.'s Certificate No. 7772 to provide Interexchange Telecommunications services is hereby canceled, effective May 30, 2001. It is further


