NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING TRANSFER OF CONTROL

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated August 17, 2001, Americatel Corporation d/b/a 10 123 America Tel d/b/a 1010 123 Americatel (Americatel) filed with this Commission an application for approval of a proposed transfer of control of Americatel. The proposed transaction will occur at the holding company level and as a consequence Pirelli S.p.A. (Pirelli) will acquire through Olimpia S.r.L. (Olimpia), an interest in Olivetti S.p.A. (Olivetti), and indirectly, Telecom Italia S.p.A. (Telecom Italia). The proposed transaction will lead to an indirect, de facto, transfer of control of Americatel. In Florida, Americatel has the authorization to provide resale of Interexchange Telecommunications (IXC) services as well as prepaid debit card service pursuant to Certificate No. 5313. Americatel has stated that the transaction will be virtually transparent to its customers in Florida and it will not affect the services being provided. Americatel has stated that it will continue to operate under its existing certificated name and tariff on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of Americatel, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that Americatel Corporation d/b/a 10 123 Americatel d/b/a 1010 123 Americatel's request for approval of transfer of control is hereby approved. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth
