BY THE COMMISSION:

By letter dated June 22, 2001, Cima Telecom, Inc., holder of Alternative Local Exchange Telecommunications Certificate of Public Convenience and Necessity No. 7890 and Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 7893, requested that Certificate No. 7890 and Certificate No. 7893 be amended to reflect the new corporate name, ANEW Broadband, Inc. Upon review of the Department of State, Division of Corporations' records, it appears that Cima Telecom, Inc. has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 7890 and Certificate No. 7893 to reflect the new corporate name.

This Order will serve as the amended Alternative Local Exchange Telecommunications Certificate of Public Convenience and Necessity No. 7890 and Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 7893 for ANEW Broadband, Inc.. ANEW Broadband, Inc. should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Cima Telecom, Inc. to change the name on Certificate No. 7890 and Certificate No. 7893 from Cima Telecom, Inc. to ANEW Broadband, Inc. is hereby approved. It is further

ORDERED that this Order will serve as ANEW Broadband, Inc.'s amended certificate and that this Order should be retained as evidence of the name change. It is further

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
