BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service
Commission that the action discussed herein is preliminary in
nature and will become final unless a person whose interests are
substantially affected files a petition for a formal proceeding,
pursuant to Rule 25-22.029, Florida Administrative Code.

Northwestern Digital Company (Northwestern Digital), holder of
Interexchange Telecommunications Certificate (IXC) of Public
Convenience and Necessity No. 7637, has requested the cancellation
of IXC Certificate No. 7637. Northwestern Digital has complied
with the provision of Rule 25-24.474(2), Florida Administrative
Code, by providing adequate notice in writing of its request for
cancellation of its IXC certificate and by submitting its
Regulatory Assessment Fees (RAFs) for the year 2001. Accordingly,
we find it appropriate to cancel IXC Certificate No. 7637,
effective December 31, 2001. We are vested with jurisdiction over
this matter pursuant to Section 364.335, Florida Statutes.


Based on the foregoing, it is
