NOTICE OF PROPOSED AGENCY ACTION
ORDER APPROVING TRANSFER OF CONTROL

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing

telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated March 1, 2002, Comcast Business Communications, Inc. (Comcast Business Communications), Comcast Corporation, and AT&T Comcast Corporation filed with this Commission an application for approval of transfer of ultimate control of Comcast Business Communications from Comcast Corporation to AT&T Comcast Corporation, the newly created ultimate parent. Comcast Business Communications is the holder of IXC Certificate No. 3545 in the name Comcast Business Communications, Inc. d/b/a Comcast Long Distance and AAV (with ALEC authority) Certificate No. 3172. Comcast Business Communications has stated that the transaction will be virtually transparent to its customers in Florida and it will not affect the services being provided. Comcast Business Communications has further stated that it will continue to operate under its existing certificated names and tariffs on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of Comcast Business Communications, Inc., Comcast Corporation, and AT&T Comcast Corporation, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that Comcast Business Communications, Inc., Comcast Corporation, and AT&T Comcast Corporation's request for approval of transfer of control of Comcast Business Communications, Inc. from Comcast Corporation to AT&T Comcast Corporation is hereby approved. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance

The action proposed herein is preliminary in nature. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, in the form provided by Rule 28-106.201, Florida Administrative Code. This petition must be received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on May 17, 2002.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this/these docket(s) before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
