## NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING TRANSFER OF ASSETS, INCLUDING CUSTOMER BASE FROM VOICE VISION INTERNATIONAL, INC. TO BAK COMMUNICATIONS, LLC

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated February 21, 2002, BAK Communications, LLC (BAK) and Voice Vision International Inc. (VVI) filed with this Commission an application for approval of transfer of assets, including customer base from VVI to BAK. BAK is the holder of Interexchange Certificate No. 8008. VVI filed for protection under Chapter 11 of the United States Bankruptcy Code. On November 6, 2001, the United States Bankruptcy Court, Central District of California, issued an Order Approving the Sale of Substantially All of VVI's Operating Assets, including its customer base, to BAK. BAK also filed with the FCC a Limited Waiver under CC Docket No. 00-257, Implementation of the Subscriber Carrier Selection Change Provisions of the Telecommunications Act of 1996, under the FCC's new streamlined regulations.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of BAK and VVI, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that BAK Communications, LLC and Voice Vision International Inc.'s request for approval of transfer of telecommunications assets, including customer base from VVI to BAK from Voice Vision International Inc. to BAK Communications, LLC is hereby approved. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto.
