NOTICE OF PROPOSED AGENCY ACTION  
ORDER APPROVING TRANSFER OF CONTROL THROUGH STOCK PURCHASE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing

telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated June 24, 2002, Reconex Acquisition Corp. (Acquisition), a subsidiary of 1-800 RECONEX, Inc., Choctaw Communications, Inc. d/b/a Smoke Signal Communications (Choctaw), and SSC Holdings, LLC (SSC) filed with this Commission a joint request for approval of transfer of control through stock purchase agreement whereby Acquisition will sell 80 percent of the outstanding stock of Choctaw to SSC, thereby making Choctaw a subsidiary of SSC. 1-800 RECONEX, Inc. is the holder of Alternative Local Exchange Telecommunications (ALEC) Certificate No. 4828. Choctaw is the holder of ALEC Certificate No. 5625. The companies have stated that the transaction will be virtually transparent to their customers in Florida and it will not affect the services being provided. The companies have further stated that they will continue to operate under their existing certificated names and tariffs on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of Acquisition, Choctaw, and SSC, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that Reconex Acquisition Corp., Choctaw Communications, Inc. d/b/a Smoke Signal Communications, and SSC Holdings, LLC's joint request for approval of transfer of control through stock purchase agreement is hereby approved. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form

This petition must be received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on August 16, 2002.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this/these docket(s) before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
