## NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING TRANSFER OF CONTROL

## BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated September 13, 2002, Global Crossing Ltd. (GCL) and GC Acquisition Limited (New GX) (and together, the Applicants) filed with this Commission an Application for Approval of Transfer of Control of Global Crossing Ltd. (Debtor-in-Possession)'s Florida Operating Subsidiaries to GC Acquisition Limited. GCL subsidiaries include Budget Call Long Distance, Inc. (Debtor-in-Possession) (Budget Call), Global Crossing North America Networks, Global Crossing (GCNAN), and (Debtor-in-Possession) Telecommunications, Inc. (Debtor-in-Possession) (GCTI) holders of Interexchange Telecommunications Service Certificates Nos. 3955, 3558, and 0063, respectively. Subsidiaries also include Global Crossing Local Services, Inc. (Debtor-in-Possession) (GCLS), and Global Crossing Telemanagement, Inc. (Debtor-in-Possession) (GC Telemanagement), holders of Alternative Local Exchange Services Certificates Nos. 5574 and 5308, respectively. The Applicants have stated that the transaction will be virtually transparent to their subsidiaries' customers in Florida and it will not affect the services being provided. The Applicants have also stated that the subsidiaries will continue to operate under their existing certificated name(s) and tariff(s) on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of GCL and New GX, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that Global Crossing Ltd. and GC Acquisition Limited's request for approval of transfer of control of Global Crossing Ltd. (Debtor-in-Possession)'s Florida Operating Subsidiaries to GC Acquisition Limited is hereby approved. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this/these docket(s) before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
