ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated October 25, 2002, USA Telephone Inc., holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 7982, requested that Certificate No. 7982 be amended to reflect the inclusion of a fictitious name, USA Telephone Inc. d/b/a CHOICE ONE Telecom. Upon review of the Department of State, Division of Corporations' records, it appears that USA Telephone Inc. has properly registered the fictitious name. Accordingly, we find it appropriate to amend Certificate No. 7982 to reflect the new operating name.

This Order will serve as USA Telephone Inc. d/b/a CHOICE ONE Telecom's amended Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 7982. USA Telephone Inc. d/b/a CHOICE ONE Telecom should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by USA Telephone Inc. to change the name on Certificate No. 7982 from USA Telephone Inc. to USA Telephone Inc. d/b/a CHOICE ONE Telecom is hereby acknowledged. It is further

ORDERED that this Order will serve as USA Telephone Inc. d/b/a CHOICE ONE Telecom's amended certificate and that this Order should be retained as evidence of the name change. It is further

ORDERED that this change will be effective upon issuance of this Order. It is further

Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
