BY THE COMMISSION:

By letter dated December 11, 2002 State Discount Telephone, L.L.C., holder of Alternative Local Exchange Telecommunications Certificate of Public Convenience and Necessity No. 7563, requested that Certificate No. 7563 be amended to reflect the new corporate name, Bellerud Communications, LLC. Upon review of the Department of State, Division of Corporations' records, it appears that State Discount Telephone, L.L.C. has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 7563 to reflect the new corporate name.

This Order will serve as the amended Alternative Local Exchange Telecommunications Certificate of Public Convenience and Necessity No. 7563 for Bellerud Communications, LLC. Bellerud Communications, LLC should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by State Discount Telephone, L.L.C. to change the name on Certificate No. 7563 from State Discount Telephone, L.L.C. to Bellerud Communications, LLC is hereby approved. It is further



Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
