ORDER APPROVING SETTLEMENT

BY THE COMMISSION:

Calpoint (Florida), LLC (Calpoint) currently holds Certificate of Public Convenience and Necessity No. 7970, issued by the Commission on December 11, 2001, authorizing the provision of Alternative Local Exchange Telecommunications service. The Division of the Commission Clerk and Administrative Services advised our staff that Calpoint had not paid the Regulatory Assessment Fees (RAFs) required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, for the year 2001. Also, accrued statutory penalties and interest charges for late RAFs payments for the year 2001 had not been paid. Calpoint was scheduled to remit its RAFs by January 30, 2002.

Pursuant to Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by

January 30 of the subsequent year. Pursuant to Section 350.113(4), Florida Statutes, the RAFs forms, for the period of January 1, through December 31, are mailed to entities at least 45 days prior to the date that payment of the fee is due. All entities that apply for certification receive a copy of our rules governing Alternative Local Exchange Telecommunications service.

On January 3, 2003, we issued Order No. PSC-03-0042-PAA-TX to impose a \$500 fine. Failure to comply or respond to this Order would result in the cancellation of Calpoint's certificate. Calpoint has since paid the 2001 and 2002 RAFs, including accrued statutory penalties and interest charges for 2001. Additionally, Calpoint has contributed \$100 to the State General Revenue Fund, and proposed to pay future RAFs on a timely basis. The contribution will be forwarded to the Department of Financial Services for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes.

We believe that the terms of the settlement agreement represent a fair and reasonable resolution of this matter. Accordingly, we hereby accept the settlement offer. We are vested with jurisdiction over this matter pursuant to Sections 364.336, 364.285, and 364.337, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Calpoint (Florida), LLC's settlement proposal set forth in the body of this Order is hereby approved. It is further

ORDERED that Calpoint (Florida), LLC's contribution will be transmitted to the Department of Financial Services for deposit in the State of Florida General Revenue Fund. It is further

ORDERED that this docket shall be closed.

Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
