BY THE COMMISSION:

By letter dated May 22, 2003, North By NortheastCom LLC, holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 8087, requested that Certificate No. 8087 be amended to reflect the new corporate name, Infone LLC. Upon review of the Department of State, Division of Corporations' records, it appears that North By NortheastCom LLC has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 8087 to reflect the new corporate name.

This Order will serve as the amended IXC Certificate of Public Convenience and Necessity No. 8087 for Infone LLC. Infone LLC should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

ORDERED by the Florida Public Service Commission that the request by North By NortheastCom LLC to change the name on Certificate No. 8087 from North By NortheastCom LLC to Infone LLC is hereby approved. It is further

ORDERED that this Order will serve as Infone LLC's amended certificate and that this Order should be retained as evidence of the name change. It is further

days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
