AMENDATORY ORDER

BY THE COMMISSION:

On October 15, 2003, we issued Order No. PSC-03-1149-PAA-TX. The main purpose of that Order imposed a penalty on Hosting-Network, Inc. for their failure to respond and address customer complaints and pay regulatory assessment fees for the year 2002. The Order also mandated that Hosting-Network, Inc. certificate be cancelled in the event the company fails to pay the aforementioned penalties. However, due to a scrivener's error, an ordering paragraph was omitted that should have stated that the company's certificate would be cancelled if payment was not received.

In light of this error, Order No. PSC-03-1149-PAA-TX is amended to reflect that if the Hosting-Network, Inc. fails to timely pay the \$50,000 penalty for violation of Rule 25-22.032(5)(a), Florida Administrative Code, Customer Complaints, within fourteen calendar days after issuance of a Consummating Order or fails to pay the \$500 penalty with interest charges for violation of Rule 25-24.835, Florida Administrative Code, Rules Incorporated, within fourteen calendar days after the issuance of the Consummating Order, Certificate No. 7840 will be canceled with an effective date of October 31, 2003, and the company must also immediately cease and desist providing competitive local exchange telecommunications services in Florida.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-03-1149-PAA-TX is hereby amended to reflect that in the event Hosting-Network, Inc. fails to timely pay the \$50,000



It is further

ORDERED that Order No. PSC-03-1149-PAA-TX is reaffirmed in all other respects.
