NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELING PAY TELEPHONE CERTIFICATE NO. 7892
AND GRANTING CERTIFICATE NO. 8463 TO PROVIDE
PAY TELEPHONE SERVICE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Edward J. Paul d/b/a Coastel Payphone Service, holder of Pay Telephone (PATS) Certificate of Public Convenience and Necessity No. 7892, has requested that Certificate No. 7892 be canceled and applied for a certificate to provide PATS service pursuant to Section 364.3375, Florida Statutes, for his/her company, Corporate Marketing, Inc. d/b/a COASTel Payphone Communications.

Edward J. Paul d/b/a Coastel Payphone Service has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its Pay Telephone certificate and by submitting its Regulatory Assessment Fees for the year PAST YEAR. Accordingly, we find it appropriate to cancel PATS Certificate No. 7892. Edward J. Paul d/b/a Coastel Payphone Service shall return to this Commission the Order granting authority to provide PATS services.

Upon consideration of Corporate Marketing, Inc. d/b/a COASTel Payphone Communication's application, it appears to be in the public interest to grant PATS Certificate No. 8463 to Corporate Marketing, Inc. d/b/a COASTel Payphone Communications. We are vested jurisdiction over this matter pursuant to Section 364.3375, Florida Statutes.

If this Order becomes final and effective, it shall serve as Corporate Marketing, Inc. d/b/a COASTel Payphone Communication's certificate. It should, therefore, be retained as proof of certification. The effective date of the cancellation of Certificate No. 7892 will be the same effective date as the new Certificate No. 8463 to avoid a break in service.

PATS providers are subject to Chapter 25-24, Florida Administrative Code, Part XI, Rules Governing Pay Telephone Service Provided by Other Than Local Exchange Telephone Companies. PATS providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed to both Edward J. Paul d/b/a Coastel Payphone Service and Corporate Marketing, Inc. d/b/a COASTel Payphone Communications for payment by January 30th. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve Edward J. Paul d/b/a Coastel Payphone Service and Corporate Marketing, Inc. d/b/a COASTel Payphone Communications from their obligation to pay RAFs.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Edward J. Paul d/b/a Coastel Payphone Service to cancel Pay Telephone Certificate No. 7892 is hereby approved. It is further

ORDERED that Edward J. Paul d/b/a Coastel Payphone Service shall remit Regulatory Assessment Fees for the year 2004. It is further

ORDERED that we hereby grant Certificate No. 8463 to Corporate Marketing, Inc. d/b/a COASTel Payphone Communications, which shall authorize it to provide Pay Telephone service, subject to the terms and conditions specified in the body of this Order. It is further


ORDERED that this Order shall serve as Corporate Marketing, Inc. d/b/a COASTel Payphone Communication's certificate and should be retained by Corporate Marketing, Inc. d/b/a COASTel Payphone Communications as proof of certification. It is further
