ORDER CANCELING PAY TELEPHONE CERTIFICATE

BY THE COMMISSION:

BellSouth Public Communications Inc., holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 4287, has requested the cancellation of PATS Certificate No. 4287. BellSouth Public Communications, Inc. has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its PATS certificate and by indicating that its Regulatory Assessment Fee (RAF) payment for 2004 will be submitted on or before May 15, 2004. Under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was active during any portion of the calendar year. Accordingly, we find it appropriate to cancel PATS Certificate No. 4287, effective April 8, 2004. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that BellSouth Public Communications Inc.'s Certificate No. 4287 to provide Pay Telephone services is hereby canceled, effective April 8, 2004. It is further

ORDERED that BellSouth Public Communications Inc. shall remit Regulatory Assessment Fees on or before May 15, 2004. It is further

ORDERED that this Docket is closed.

Any party adversely affected by the Commission's final action in this matter may request:  
1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the

Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
