ORDER ESTABLISHING 2005 DOCKET NUMBER

BY THE COMMISSION:

To avoid confusion and reduce administrative handling in this active, continuing docket, the Commission hereby establishes a new docket number for the calendar year 2005. Beginning January 3, 2005, Docket No. 040004-GU, In re: Natural Gas Conservation Cost Recovery, will be identified as Docket No. 050004-GU.

The Commission establishes this new docket for administrative convenience only, and retains continuing jurisdiction over matters considered in previous natural gas conservation cost recovery dockets.

All parties shall use the new docket number on the effective date of January 3, 2005, and thereafter. Intervenors will not remain parties to this docket unless they notify the Division of the Commission Clerk and Administrative Services in writing of their intent to remain parties. Intervenors and interested persons must reestablish their status to remain on the docket mailing list.

ORDERED by the Florida Public Service Commission that beginning January 3, 2005, all matters previously the subject of Docket No. 040004-GU shall become the subject of Docket No. 050004-GU. It is further

ORDERED that the Commission shall retain jurisdiction over matters considered in previous energy conservation cost recovery dockets.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in

the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of the Commission Clerk and Administrative Services, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
